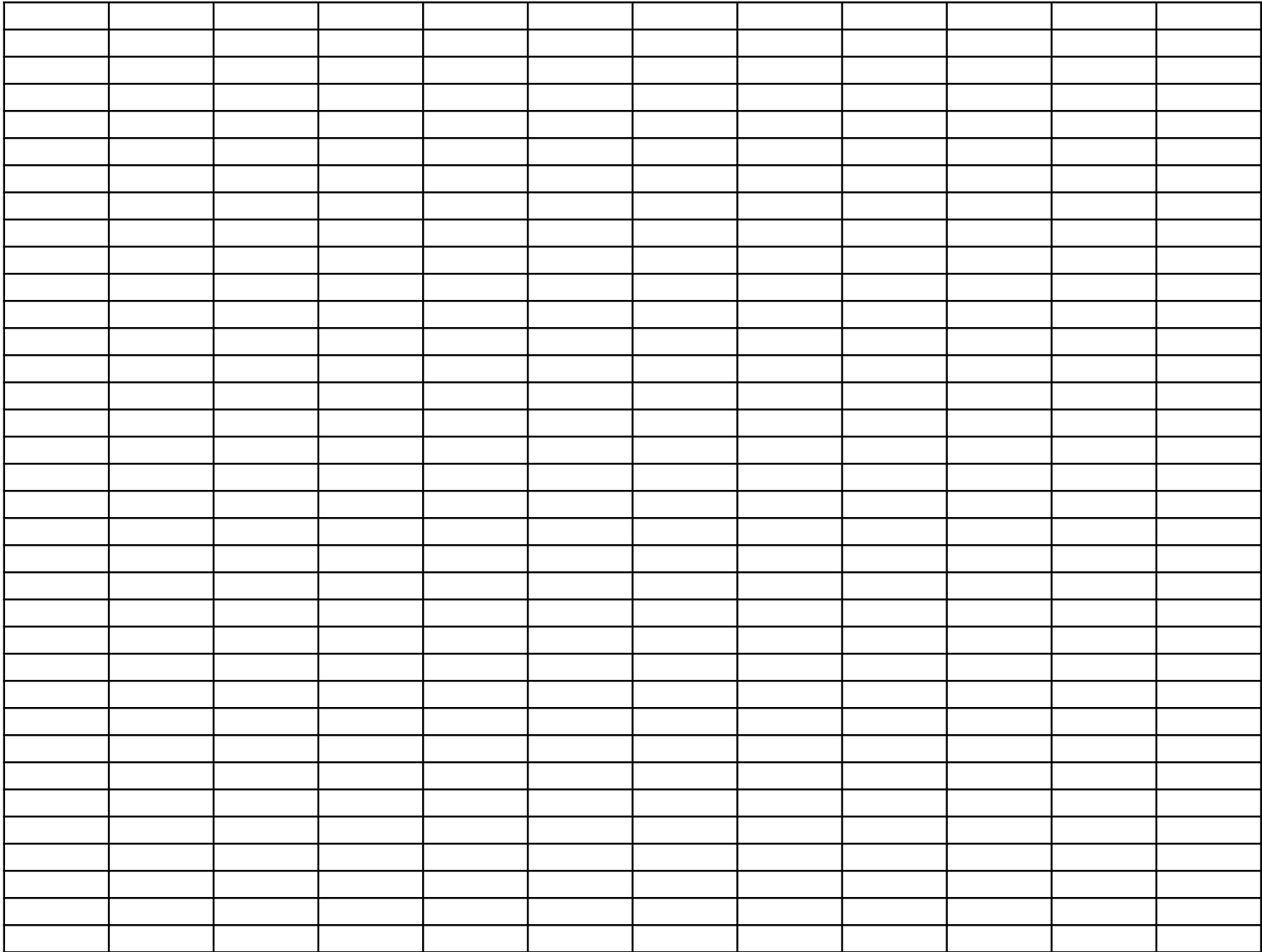


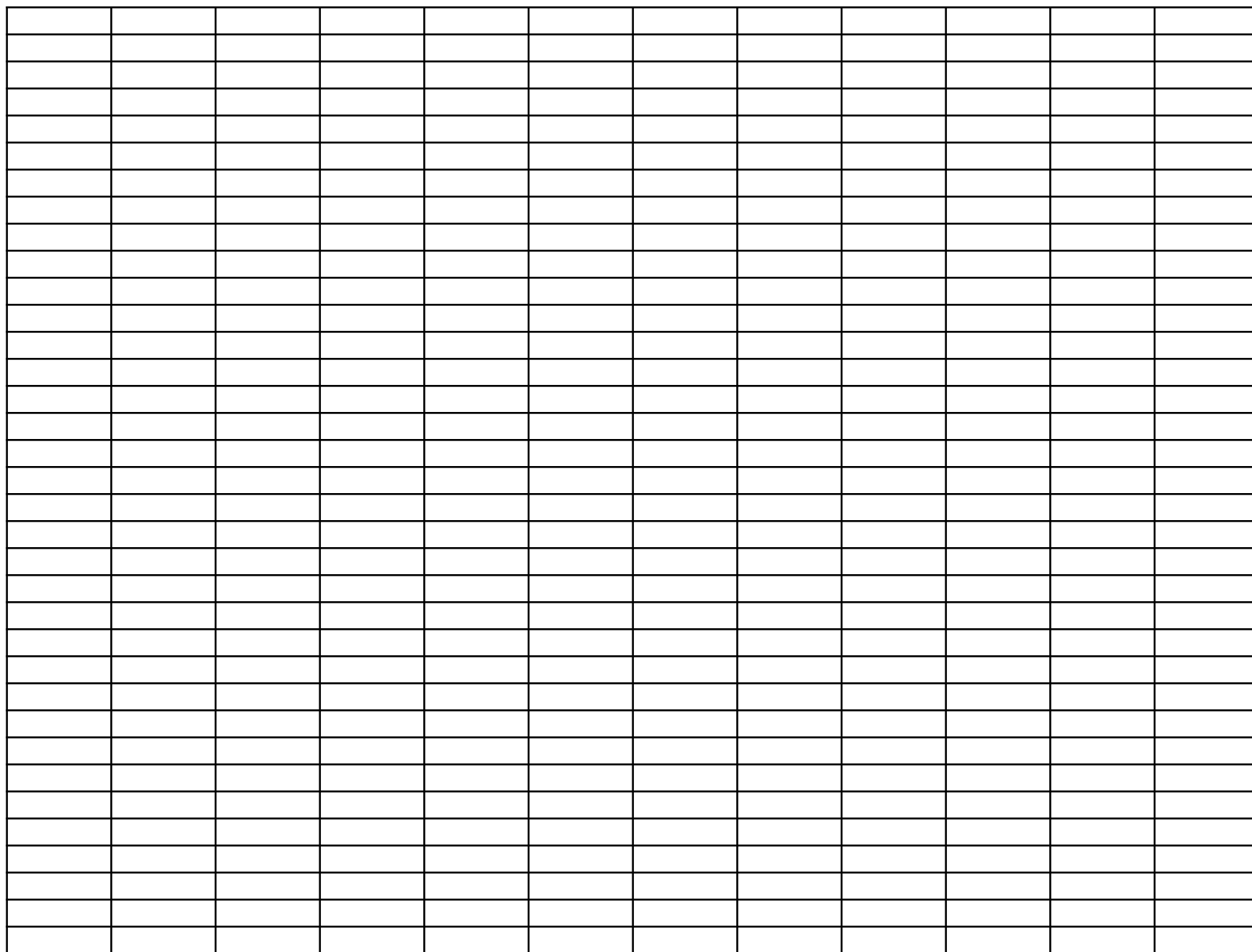


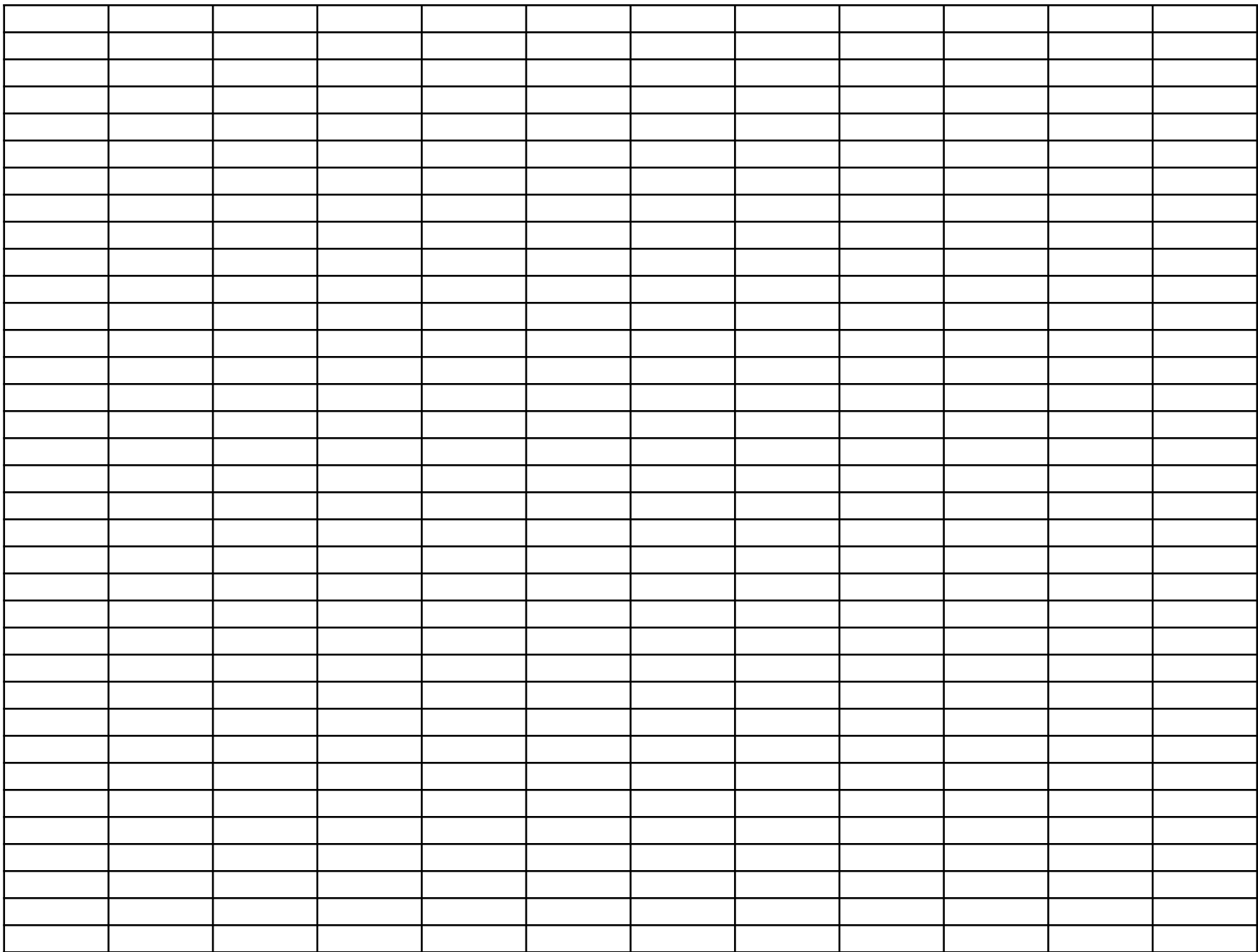


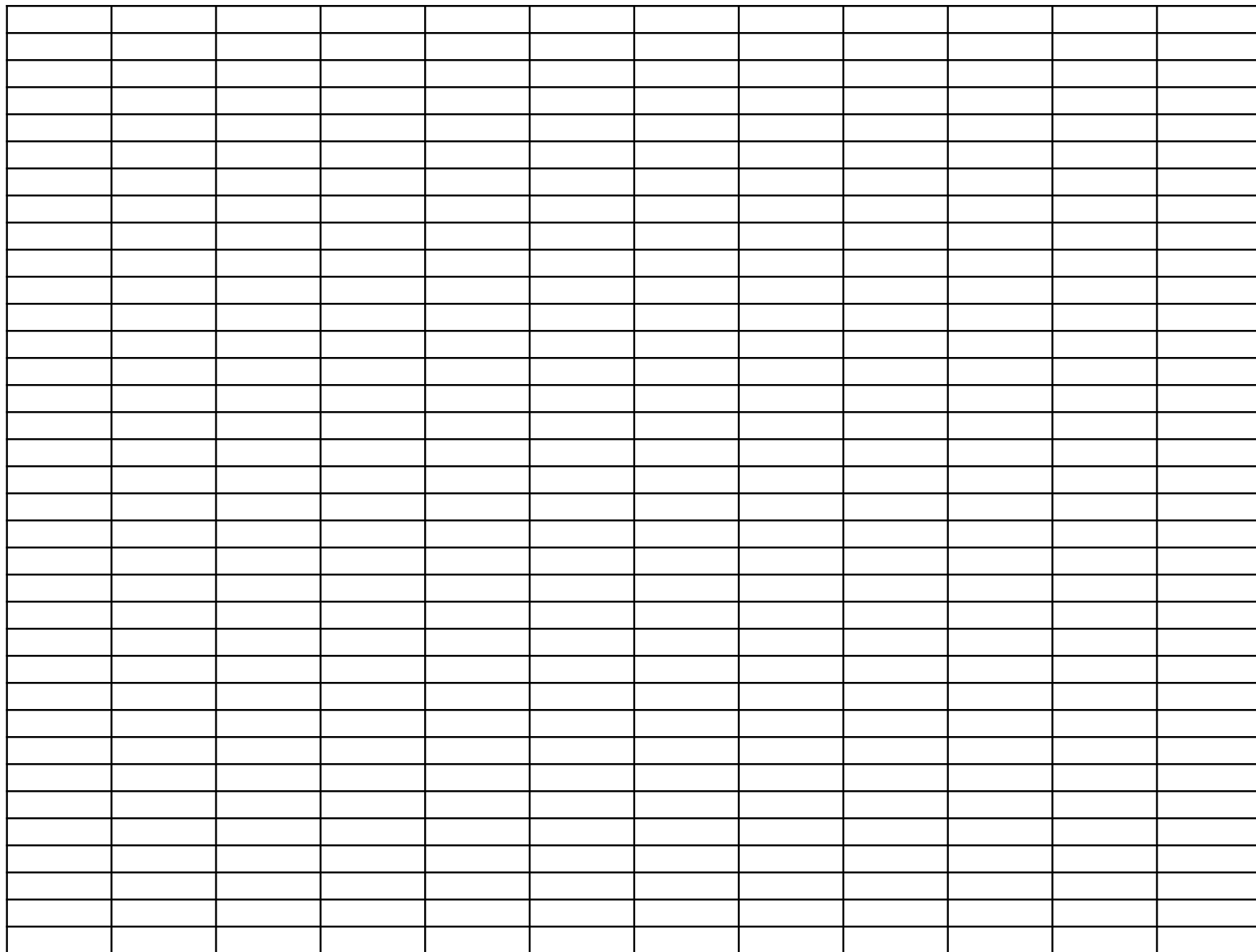


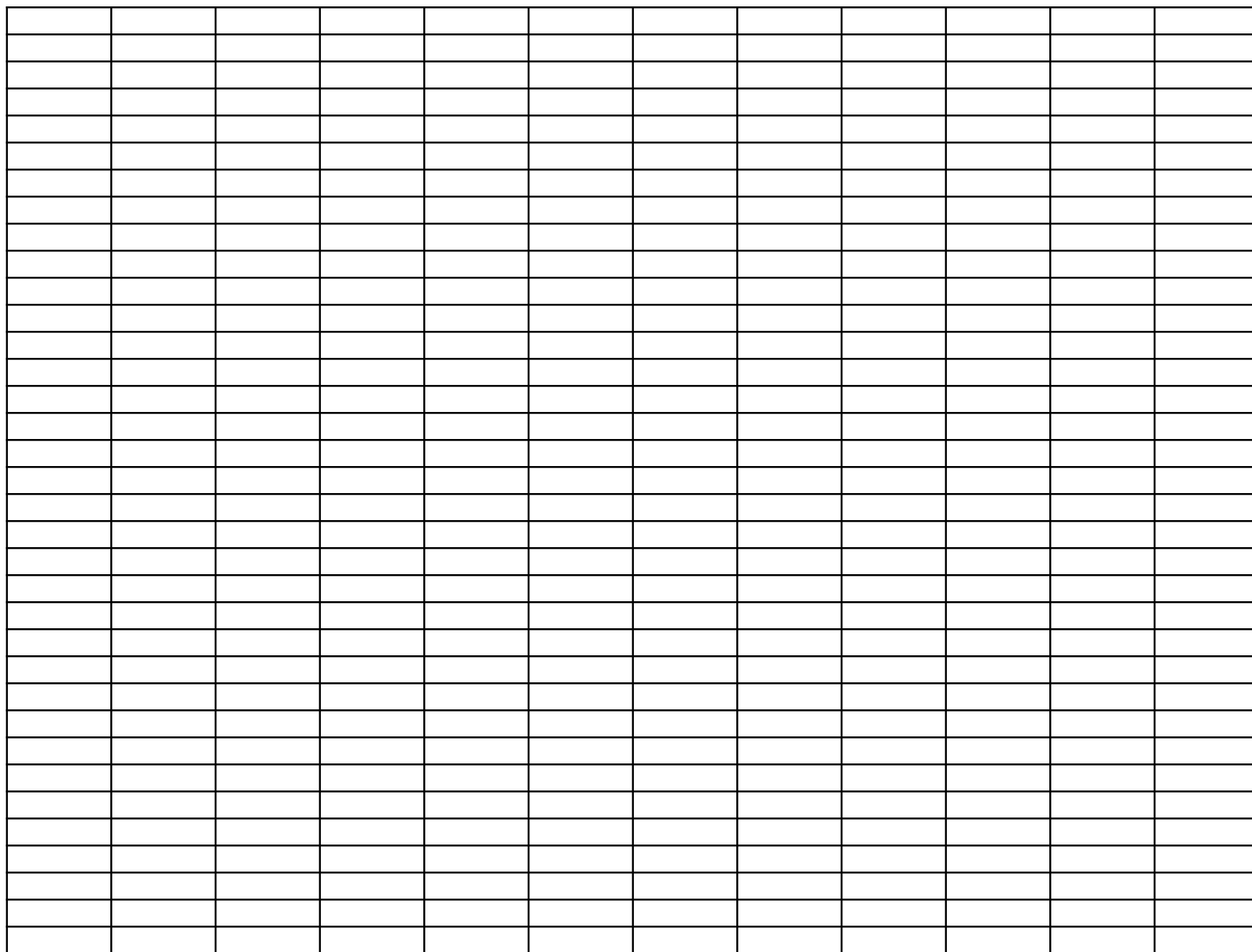


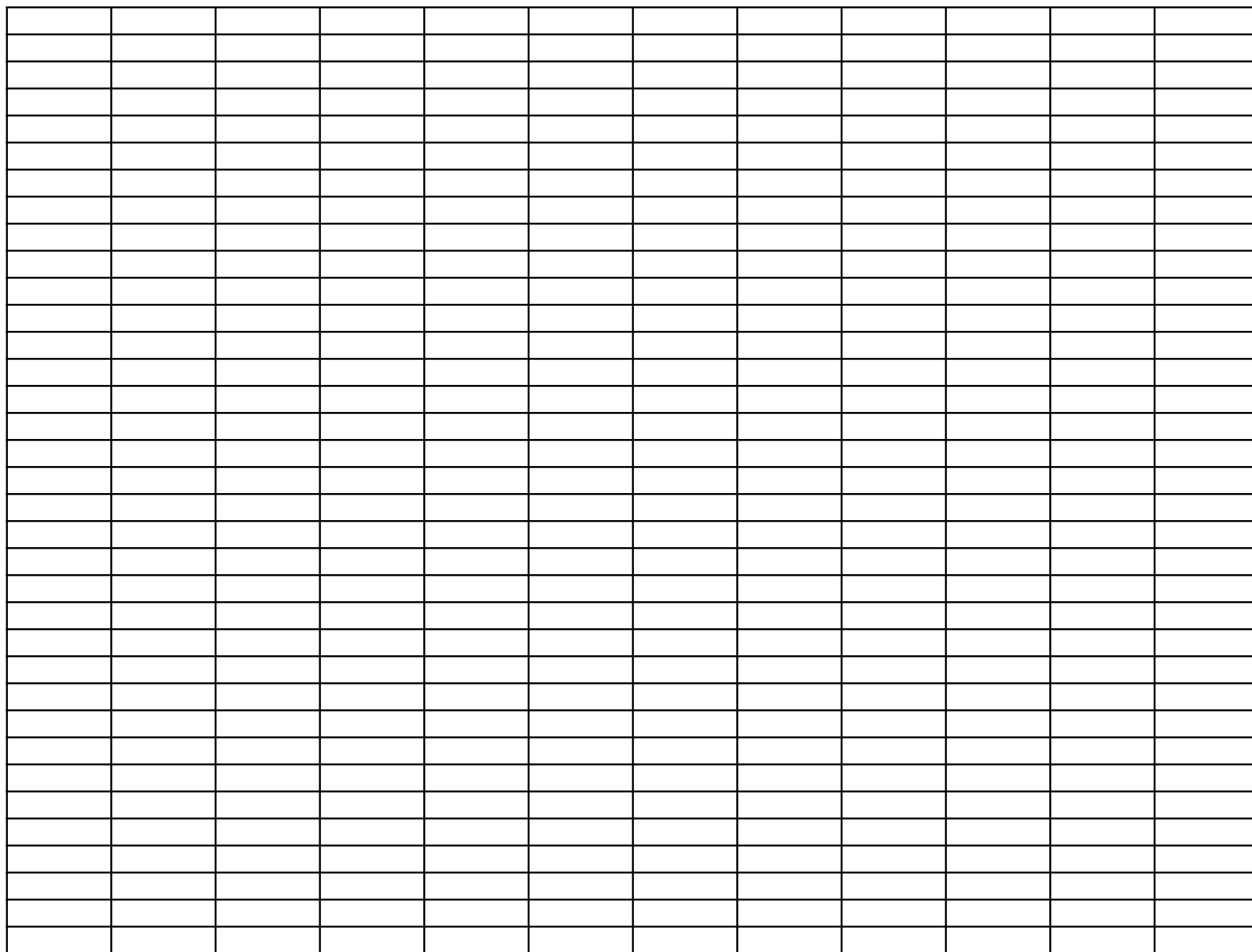


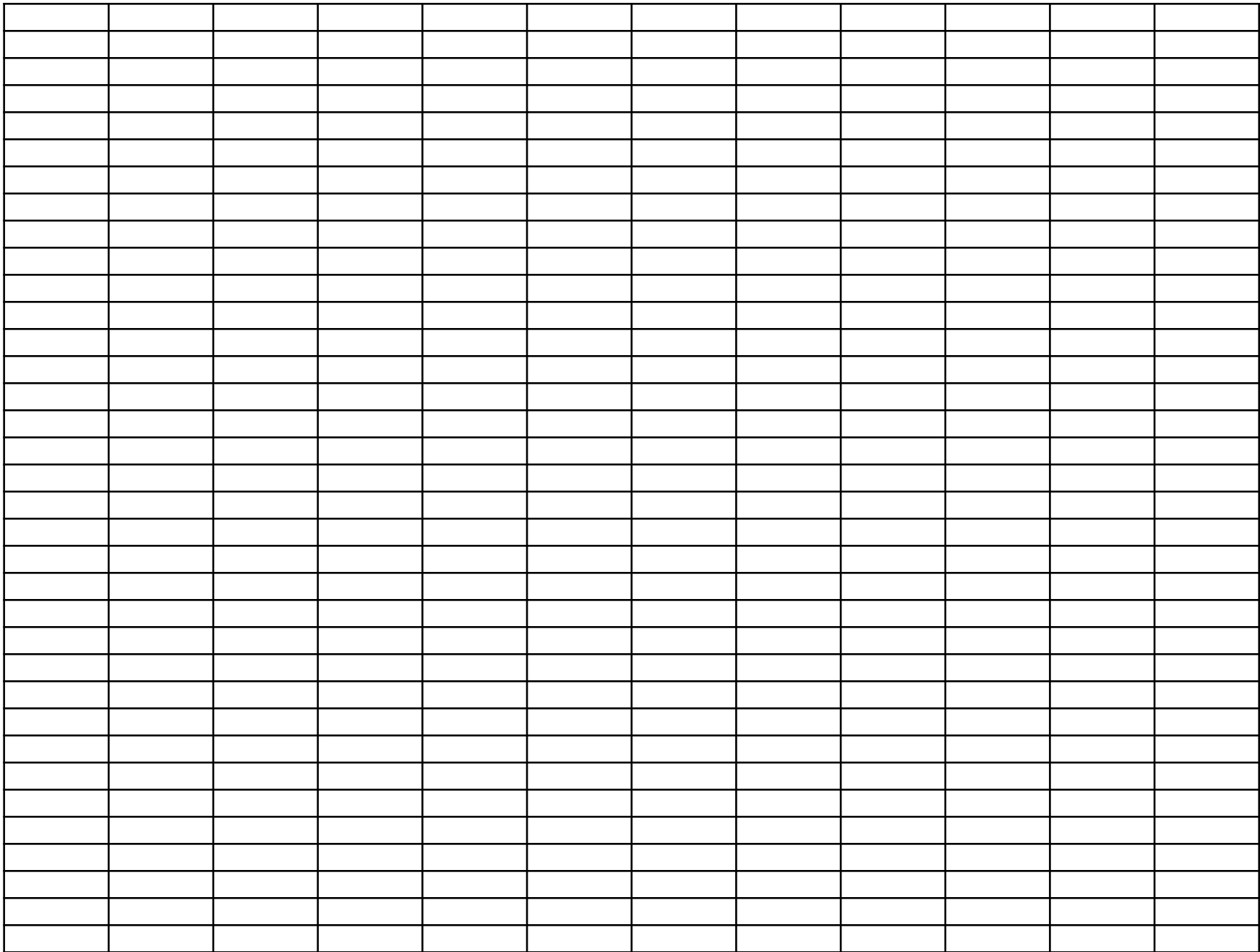


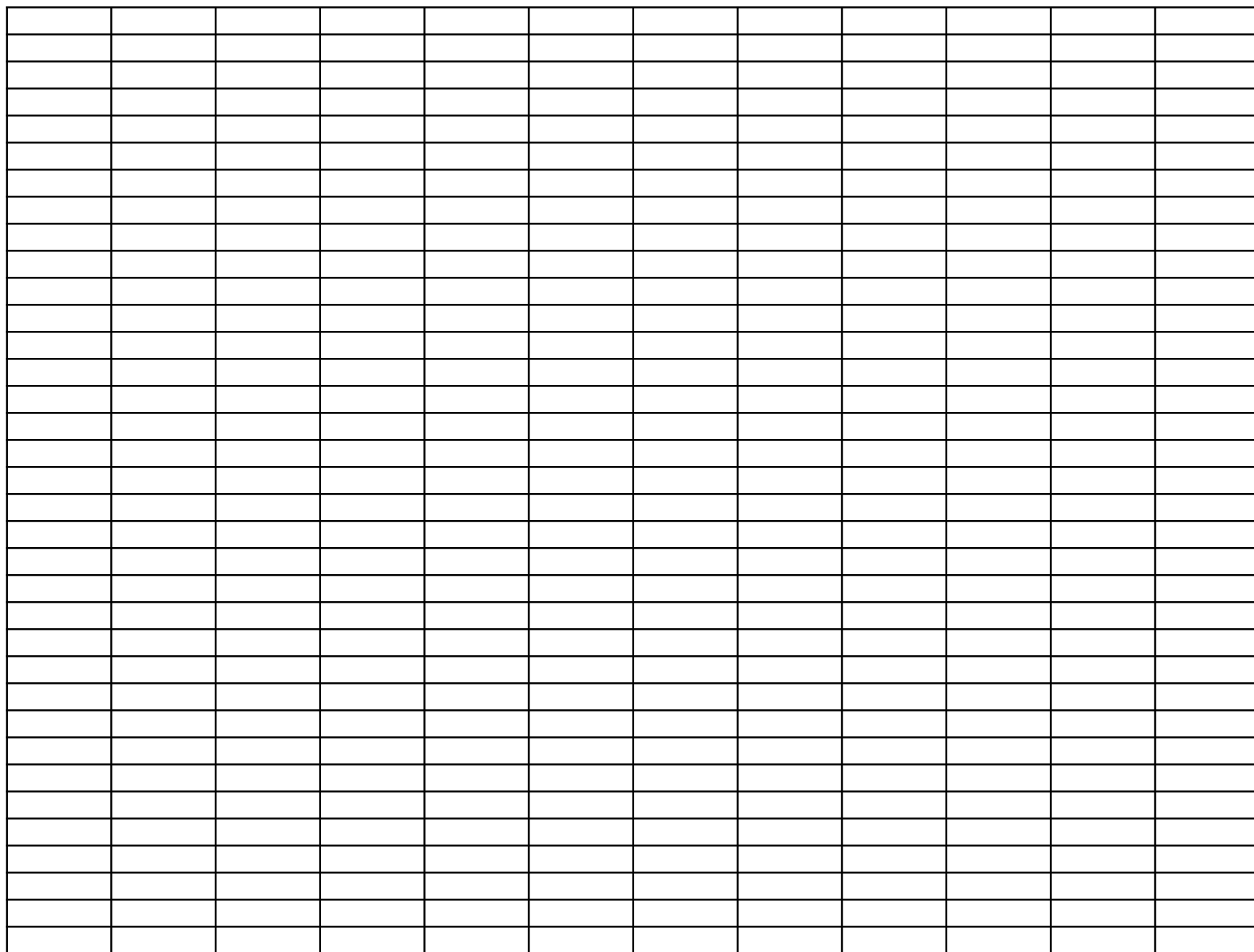


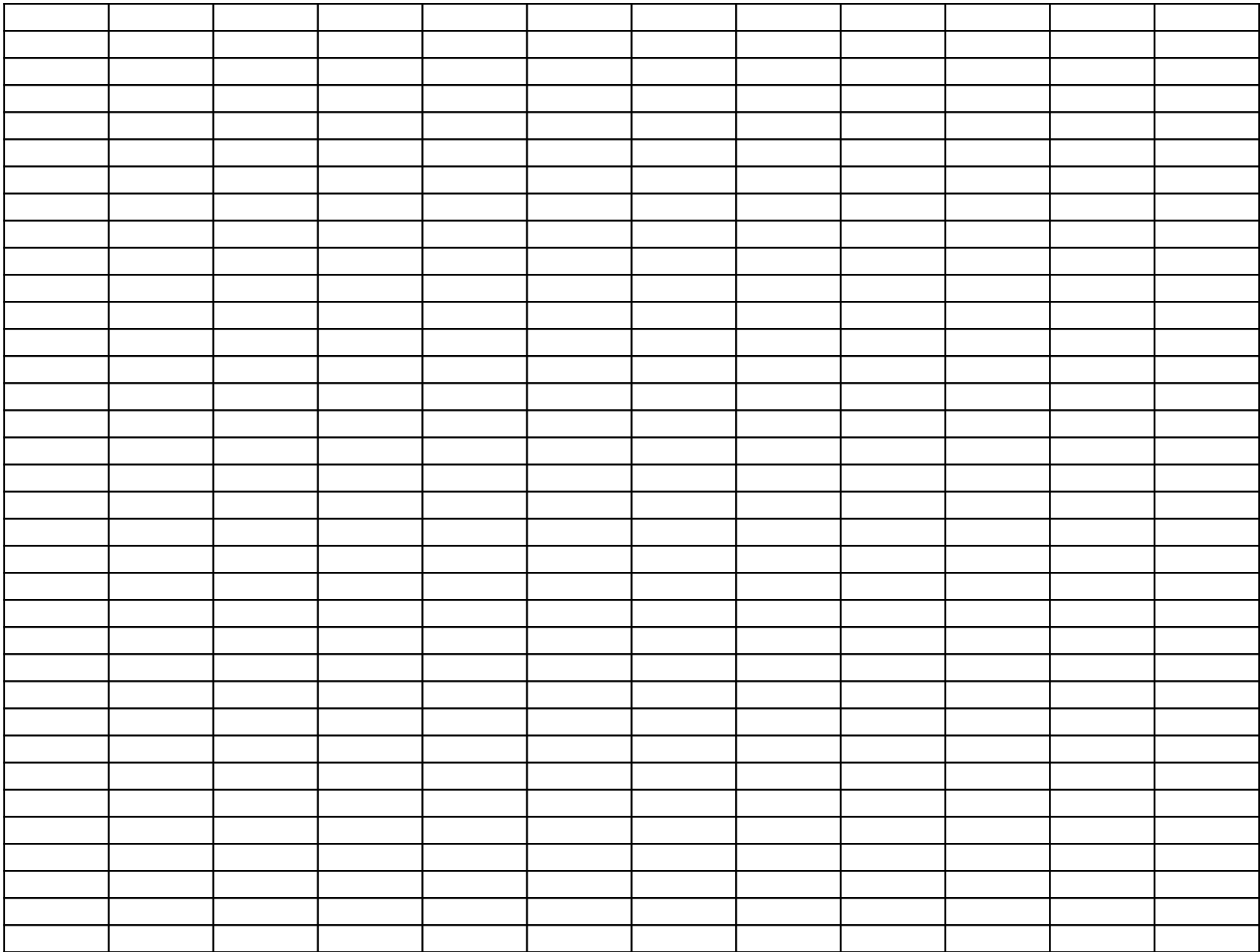


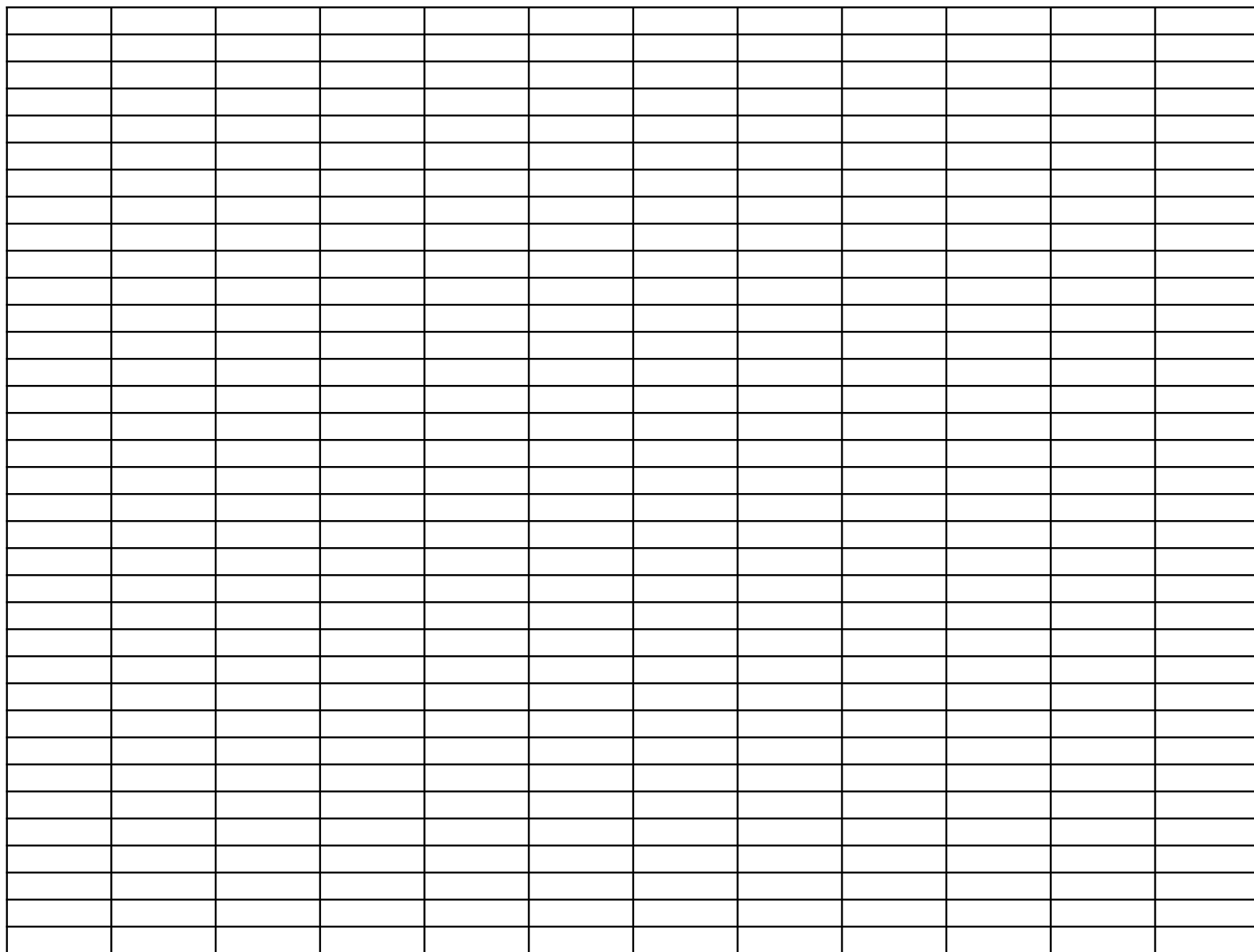


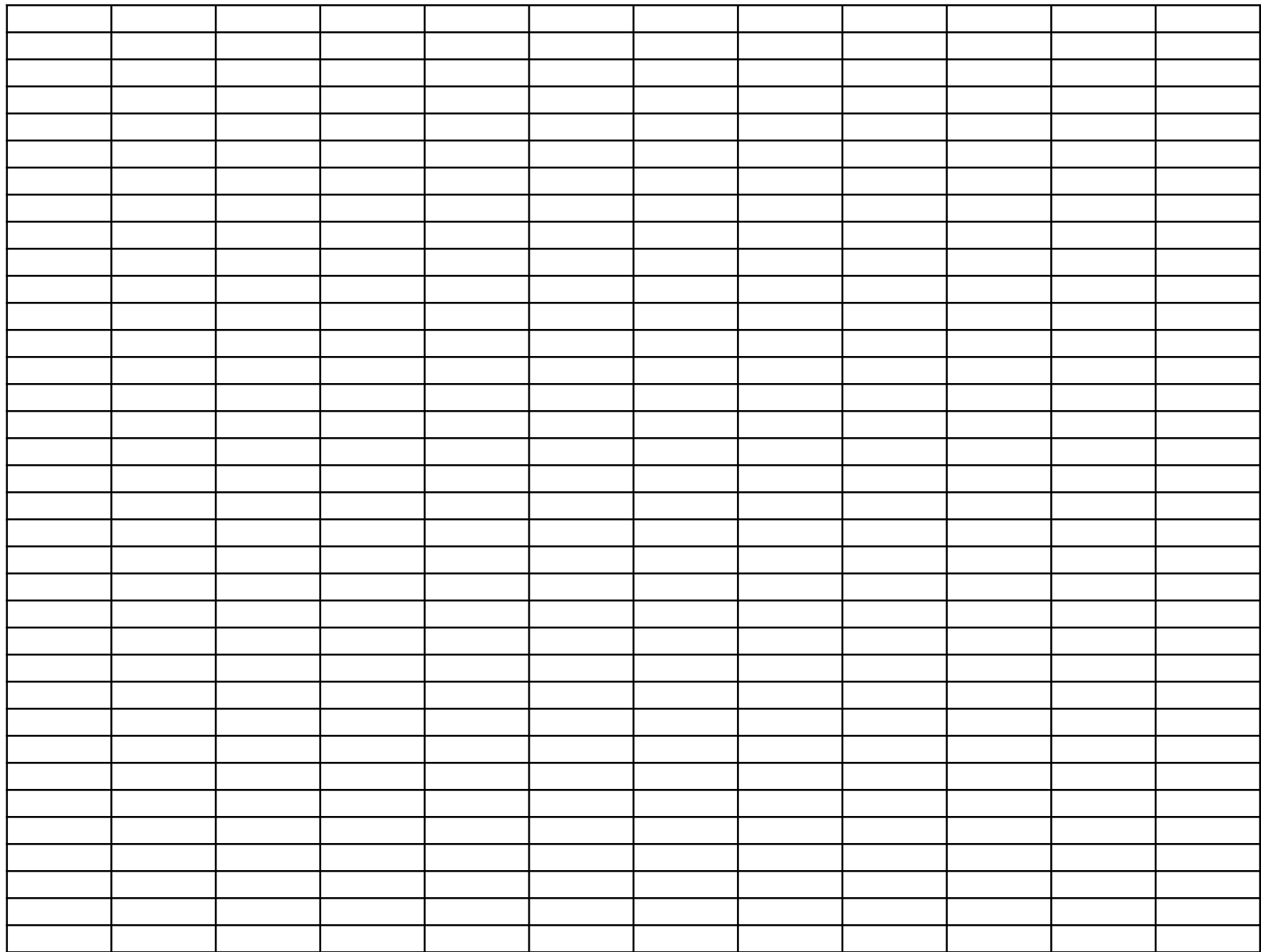












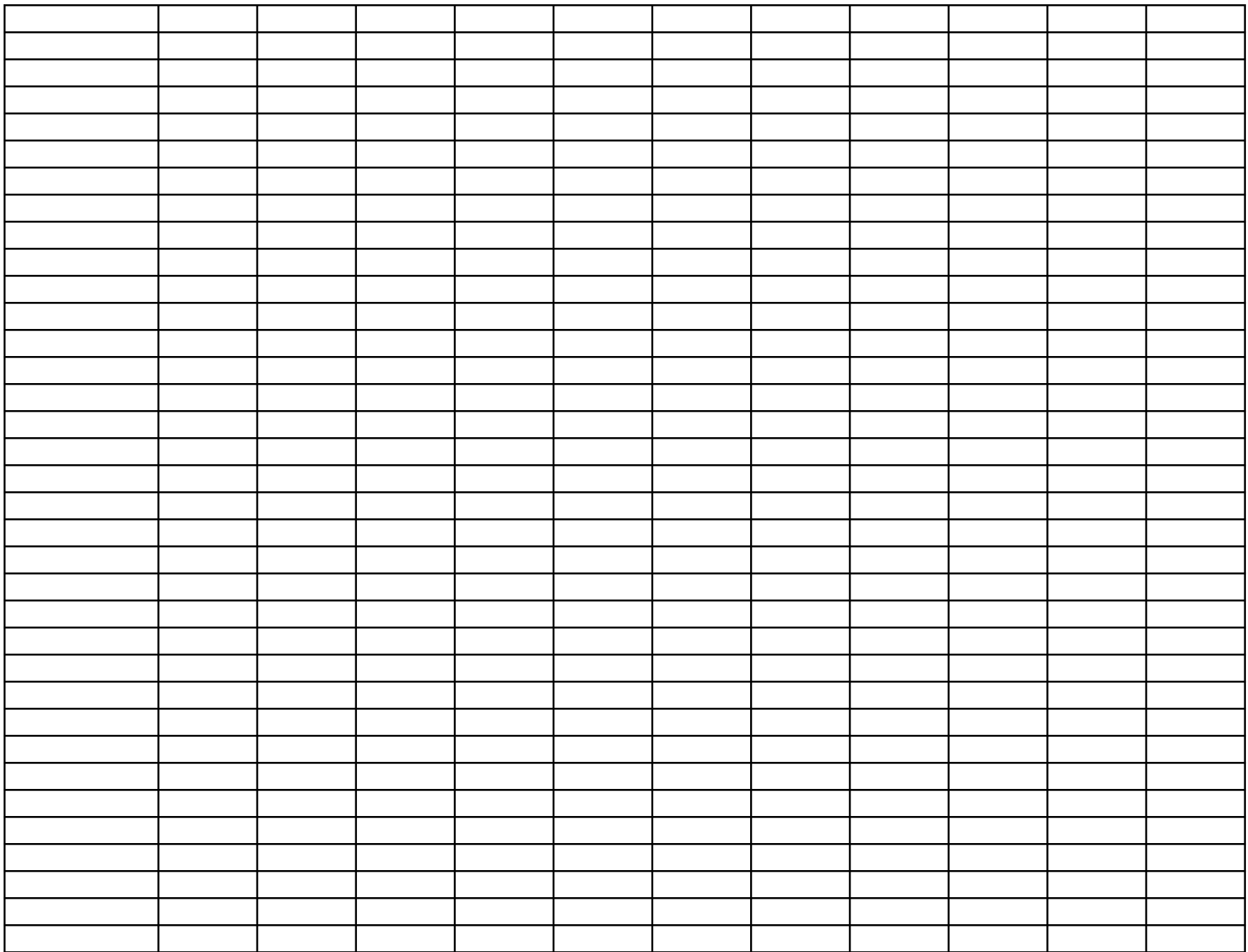
Methodology

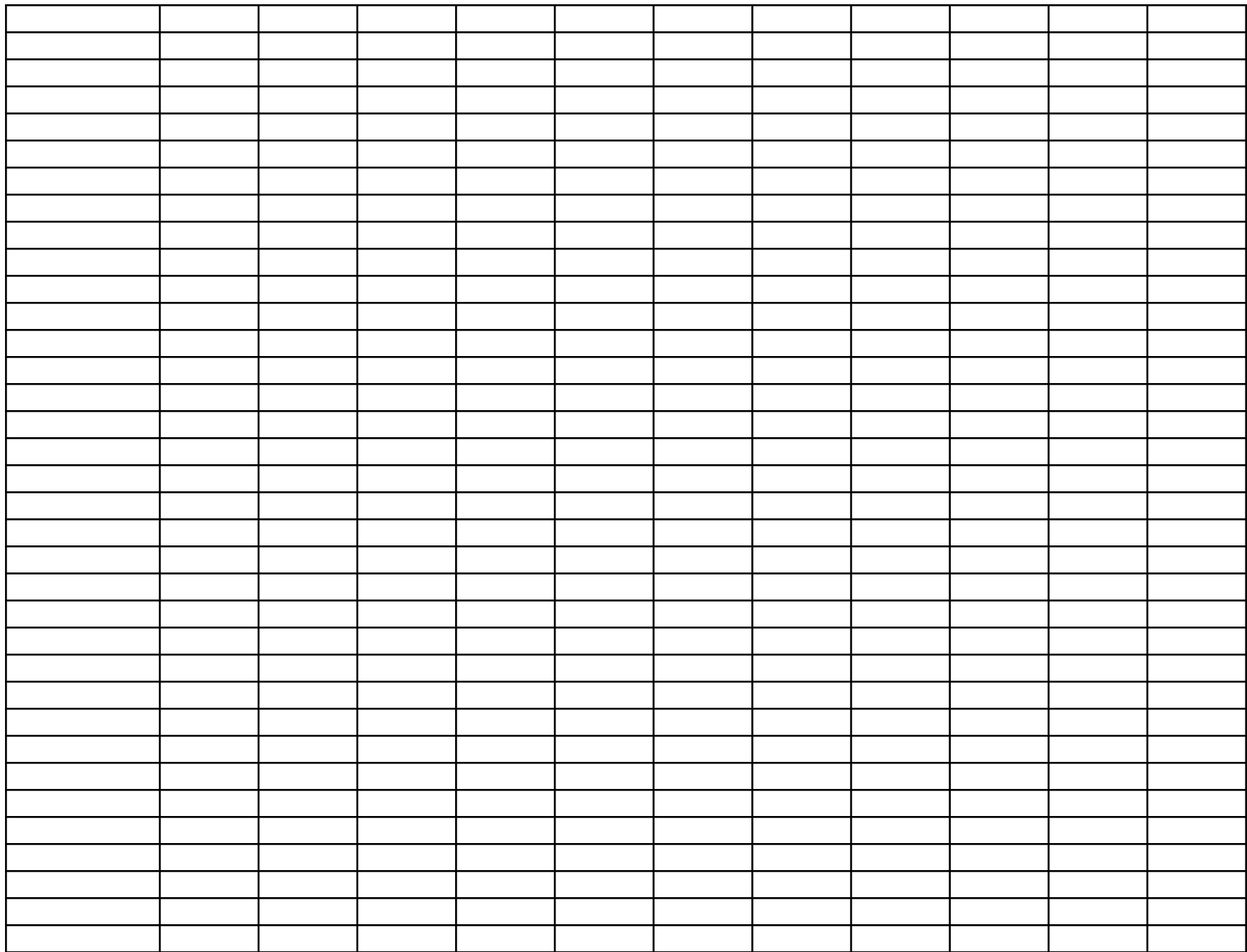
We began with a keyword search in the Lexis+ legal database for state and federal court cases decided in 2022, reviewed each case for its filing date, and included cases filed between January 1 and December 31. This information was generally harder to find for state versus federal courts, and was more challenging for some states than others. Where a filing date was not available in an opinion or otherwise through Lexis, we made a good faith effort to confirm through the Bloomberg Law Docket Search, which also has state court access limitations, or through a Google search. Because Lexis only includes written opinions, we then hand added relevant cases filed within our date range that our search did not capture but that appear in the publicly available Democracy Docket website.

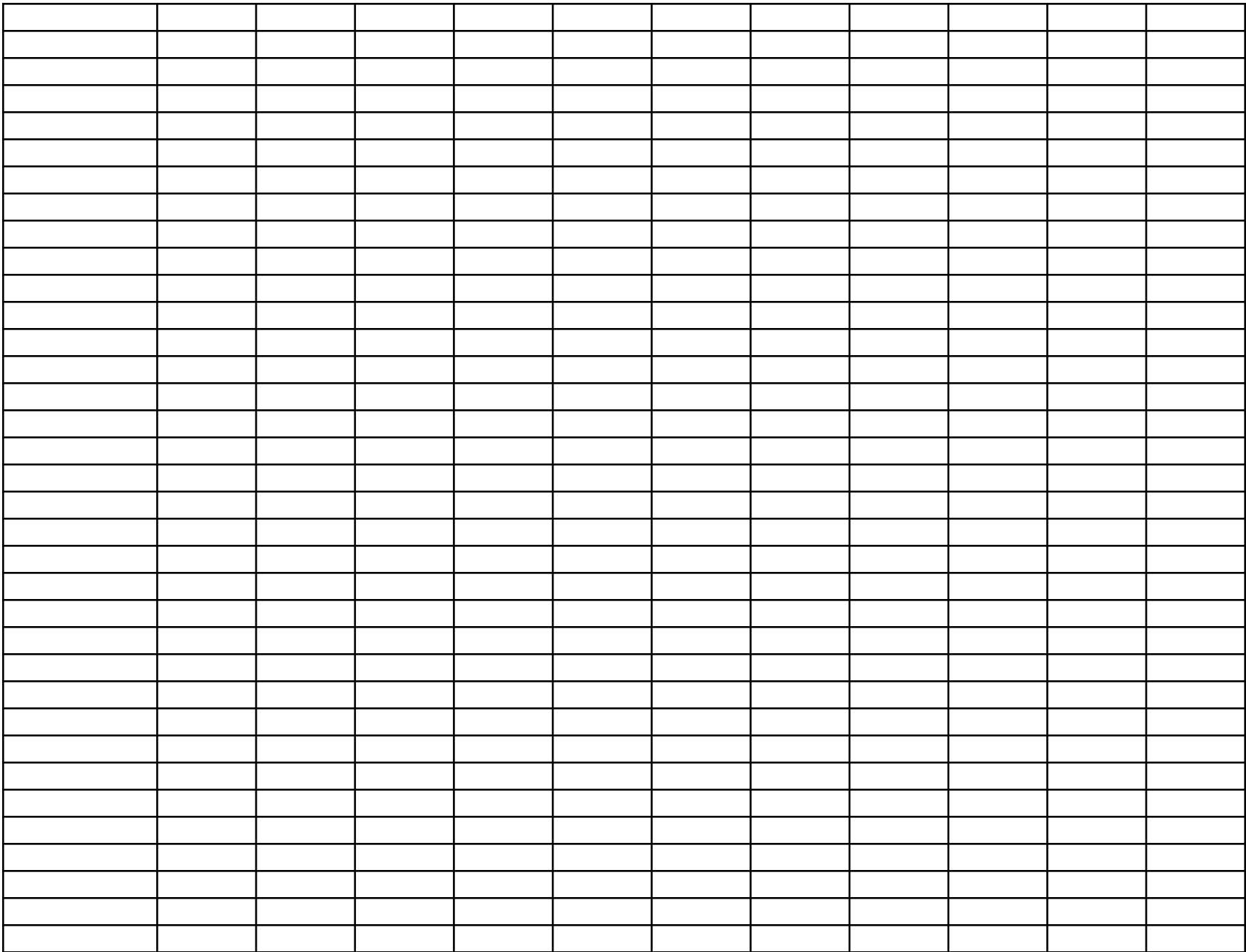
For 2018 and 2020 state- and federal-court election litigation, we followed the same steps as we did for 2022, and then cross-checked our results against a database election law scholar Rick Hasen maintains. Hasen's database was published in the *Election Law Journal* and covers election litigation from 2018 through 2020 and likewise drew from Lexis. As with the 2022 data, we also hand-added additional cases that appear on the Democracy Docket website that were not in Lexis.

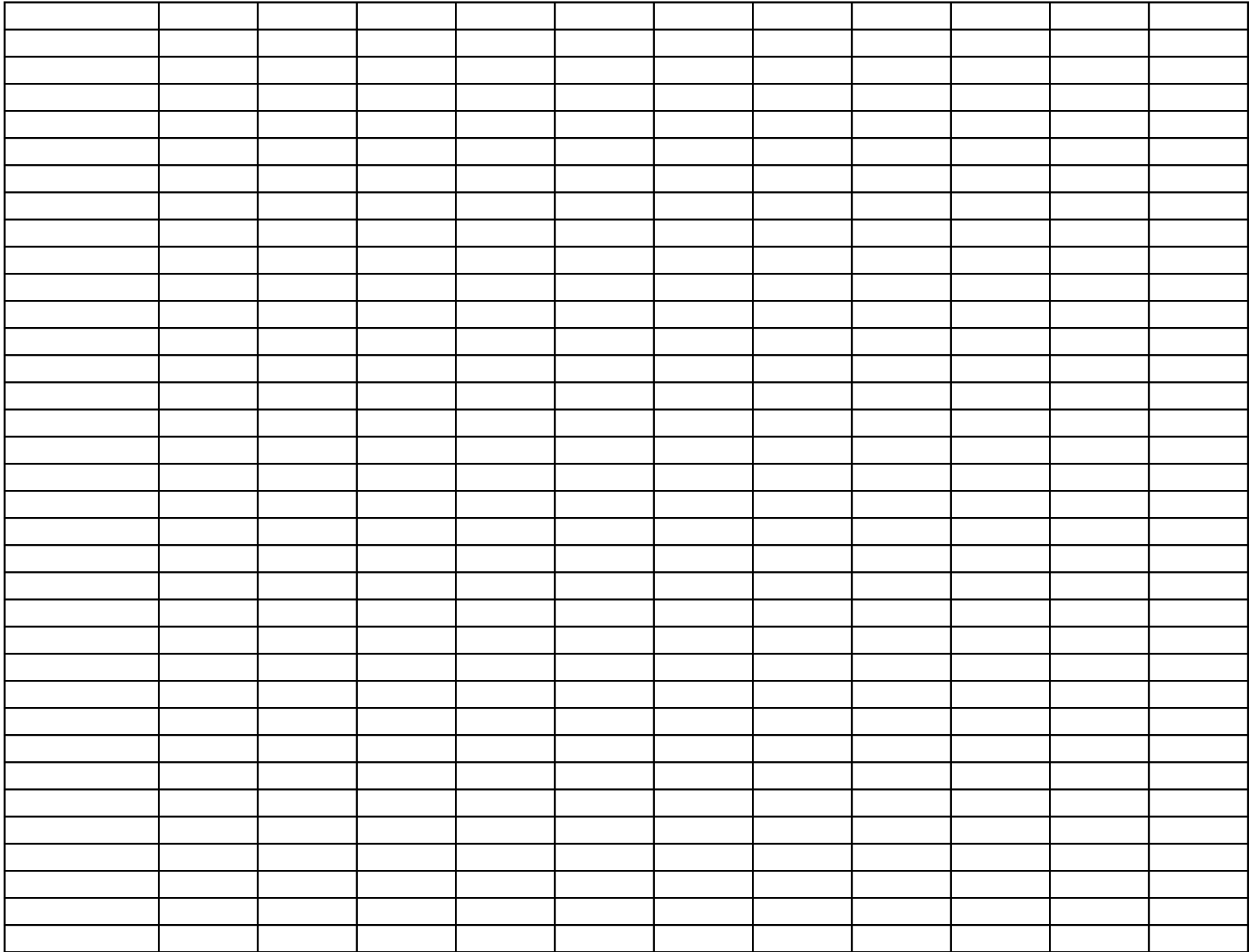
We categorized cases based on the substance of each case. Descriptions of each category can be found in a separate tab of this spreadsheet. Where a case could fit within multiple categories, we looked for the gravamen of the complaint—i.e., the claim the case appeared to really turn on—to place each case in a single category.

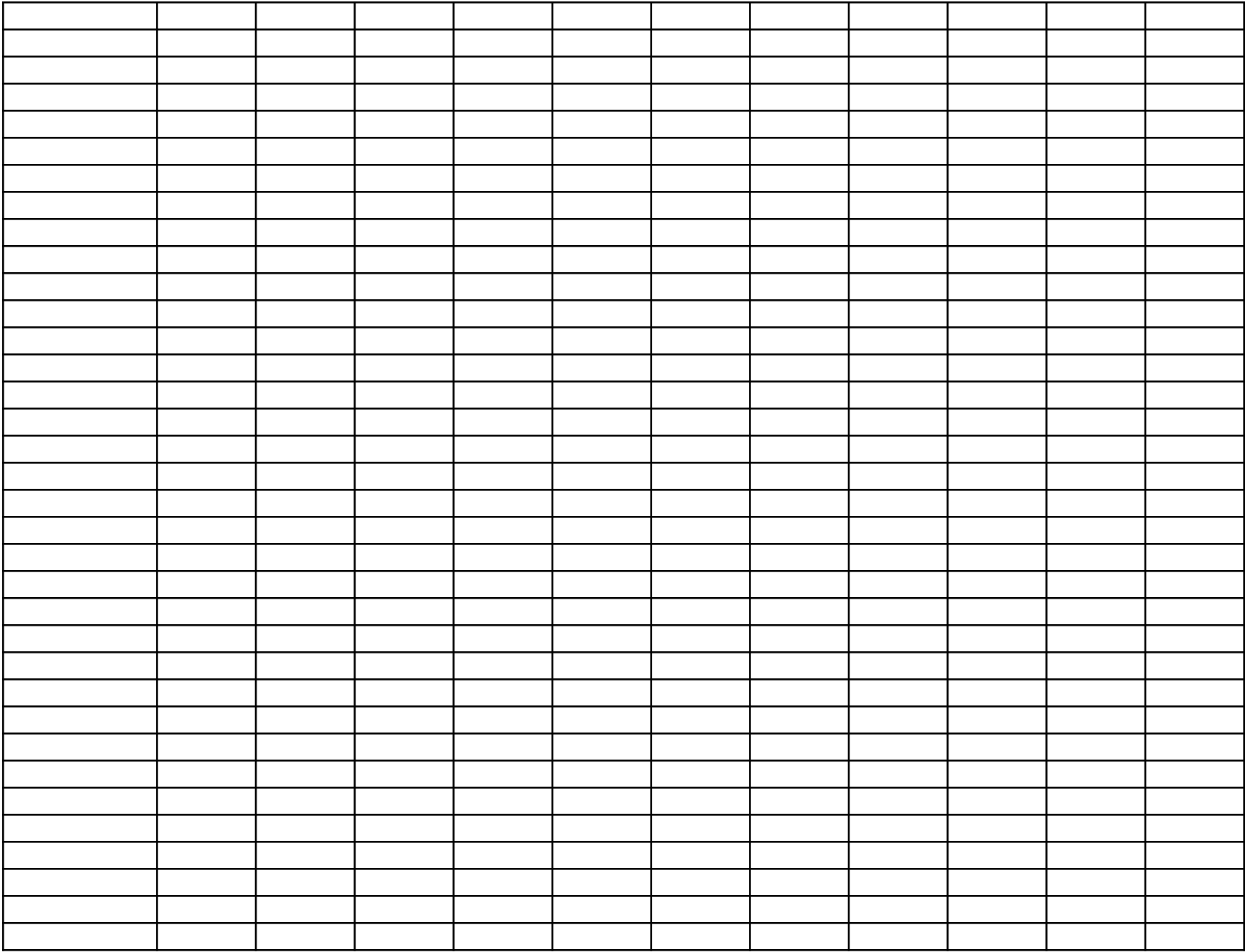
We also found that Lexis backfills its data for both state and federal courts, so there may be cases that match our search and temporal criteria that were added to the Lexis database after we conducted this study.

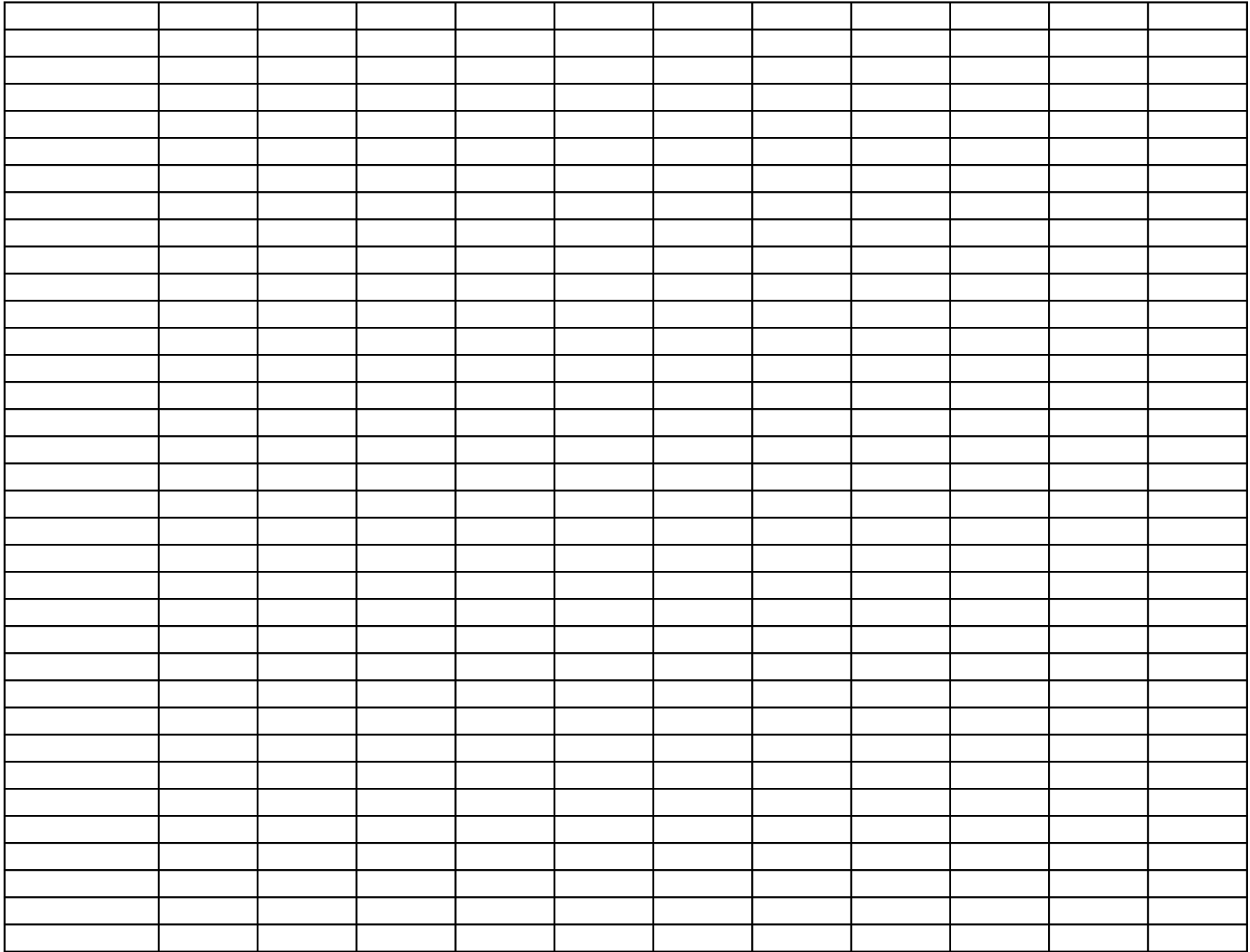


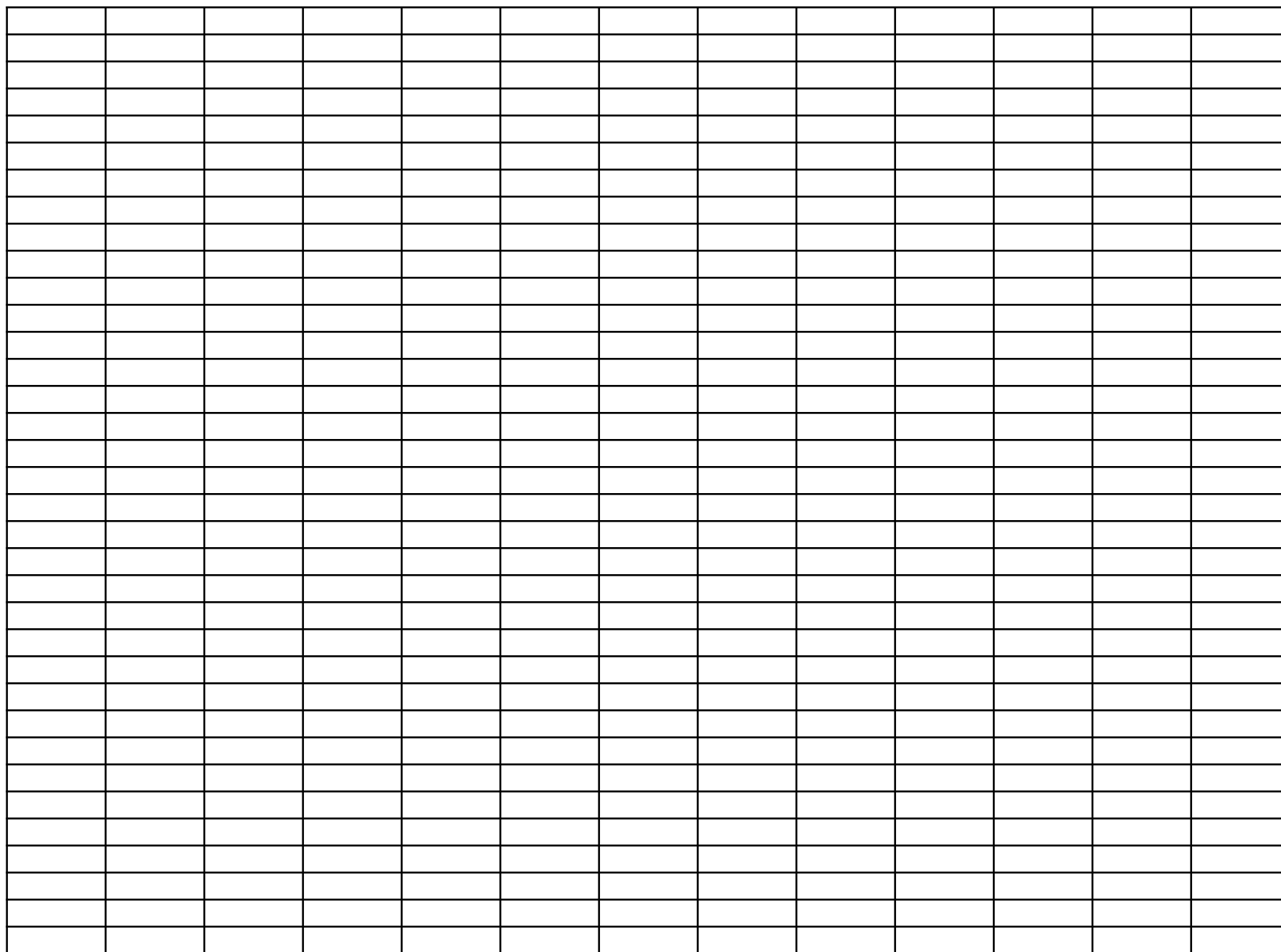


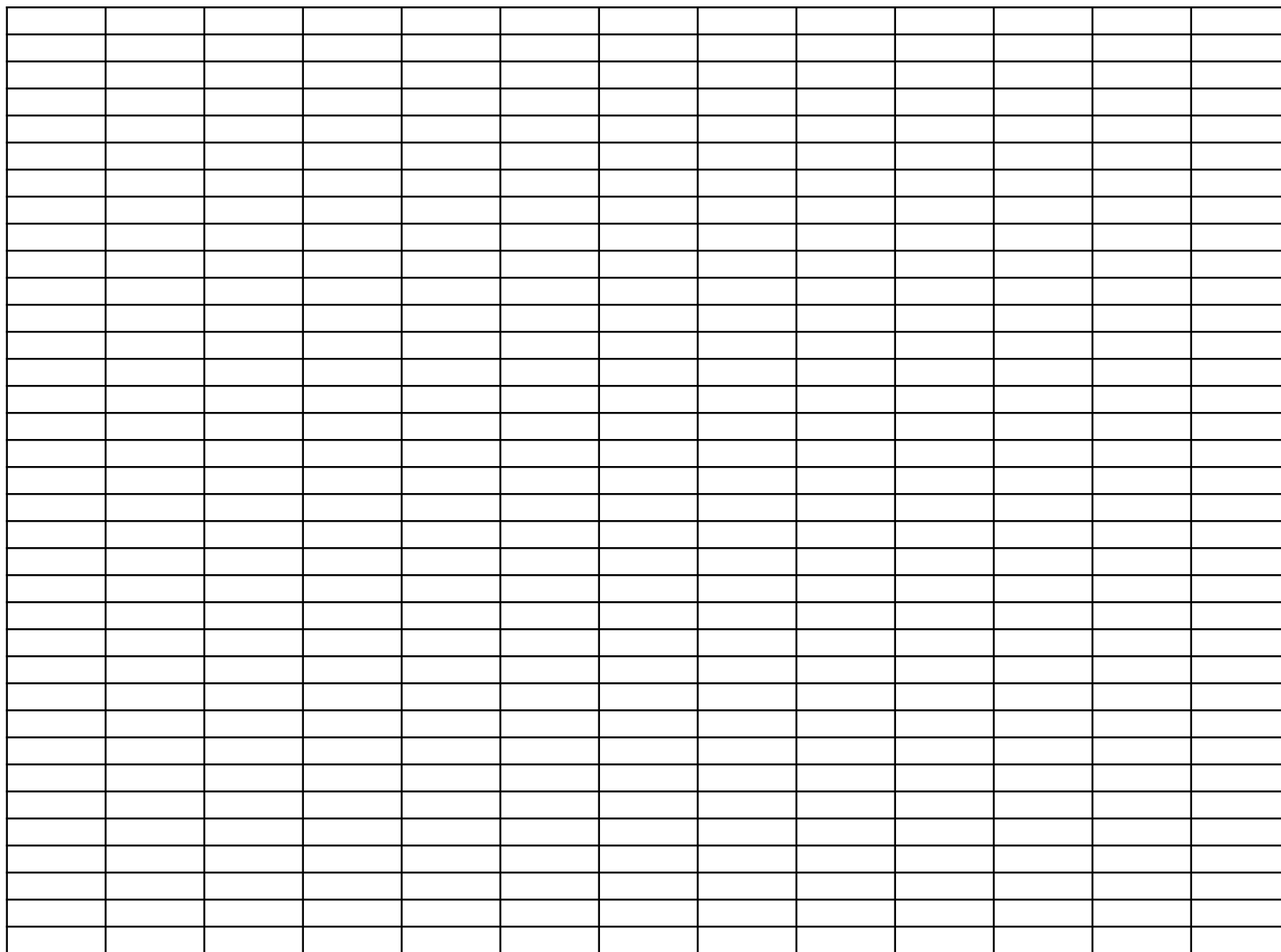


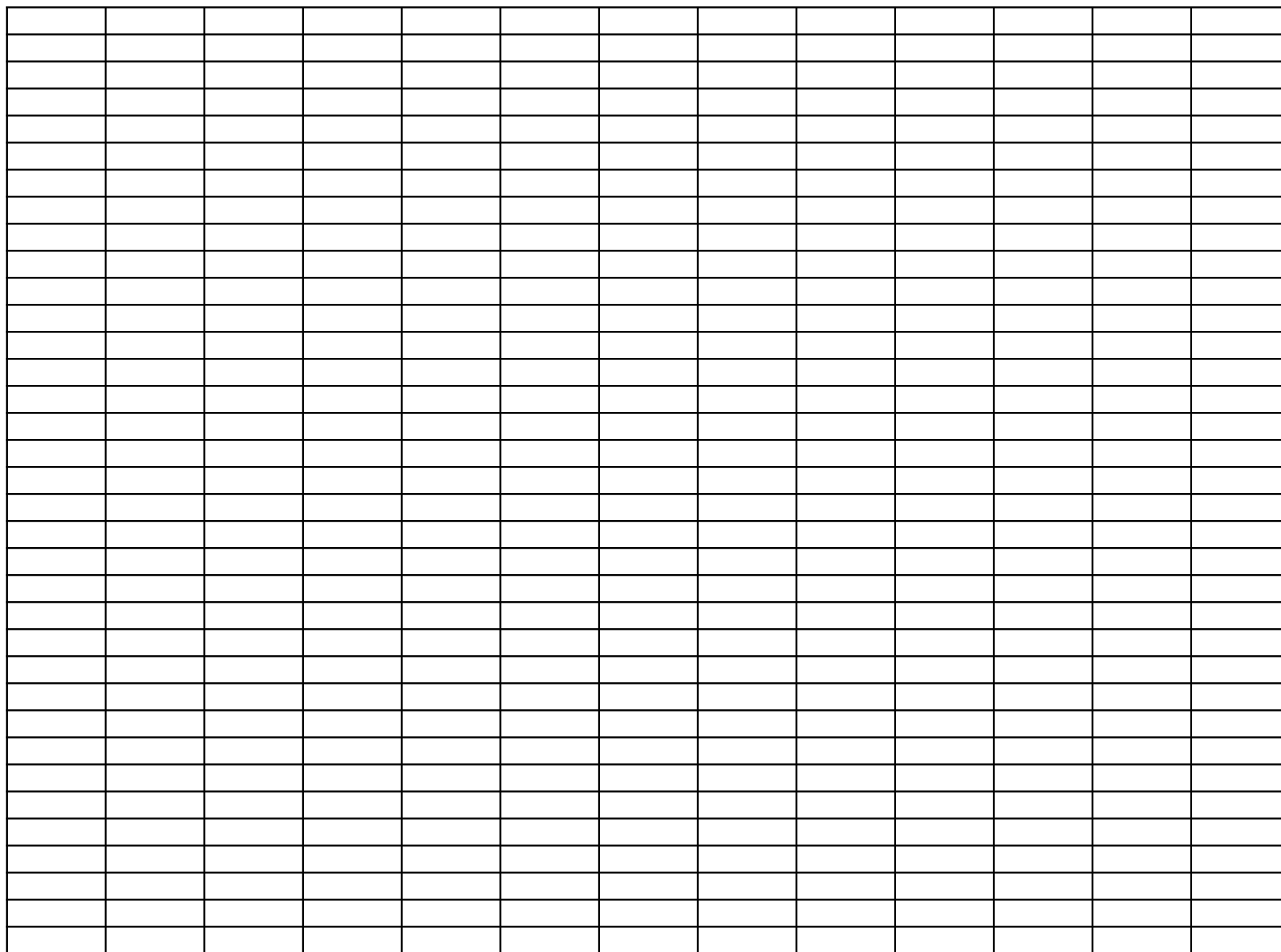


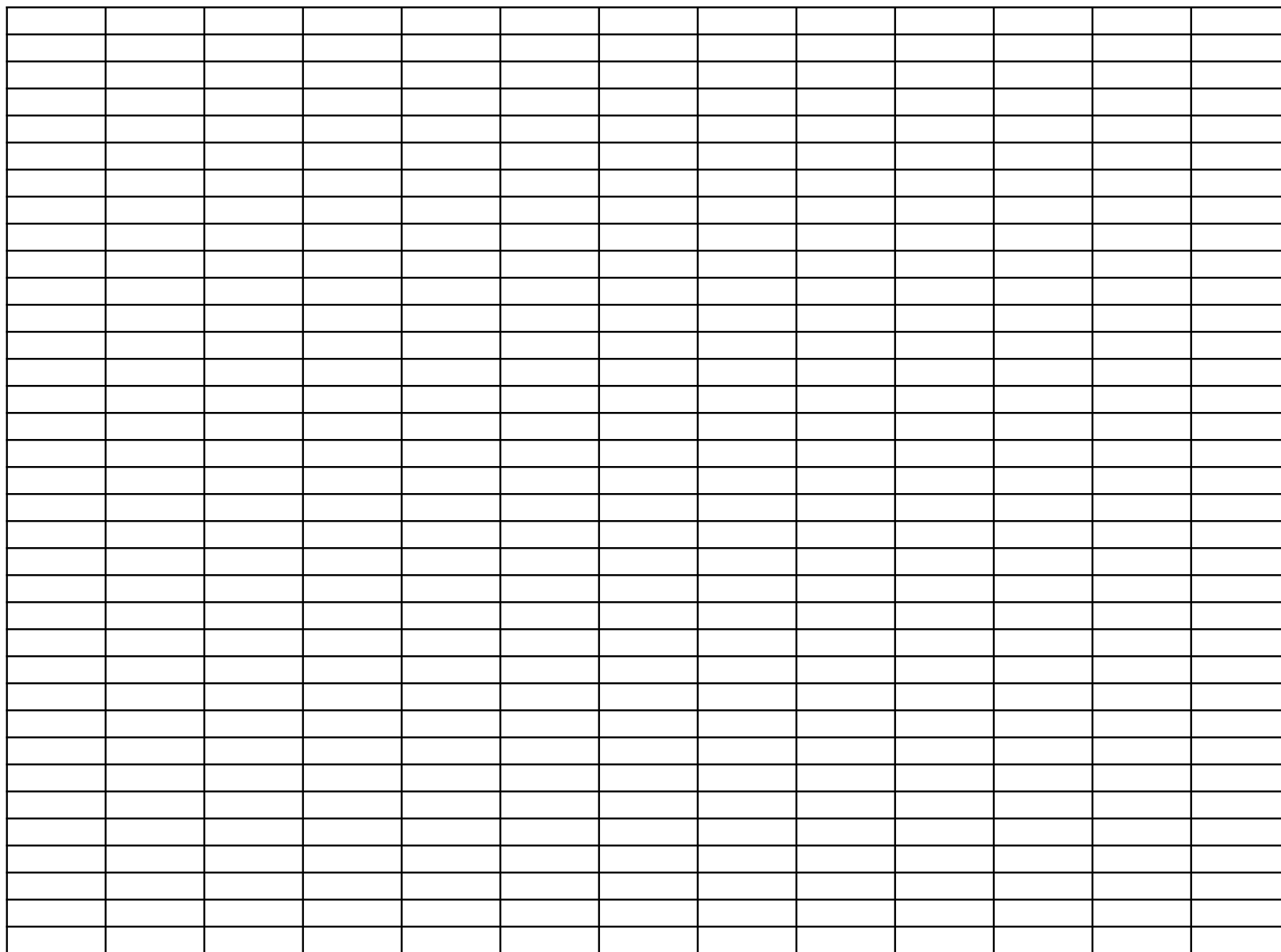


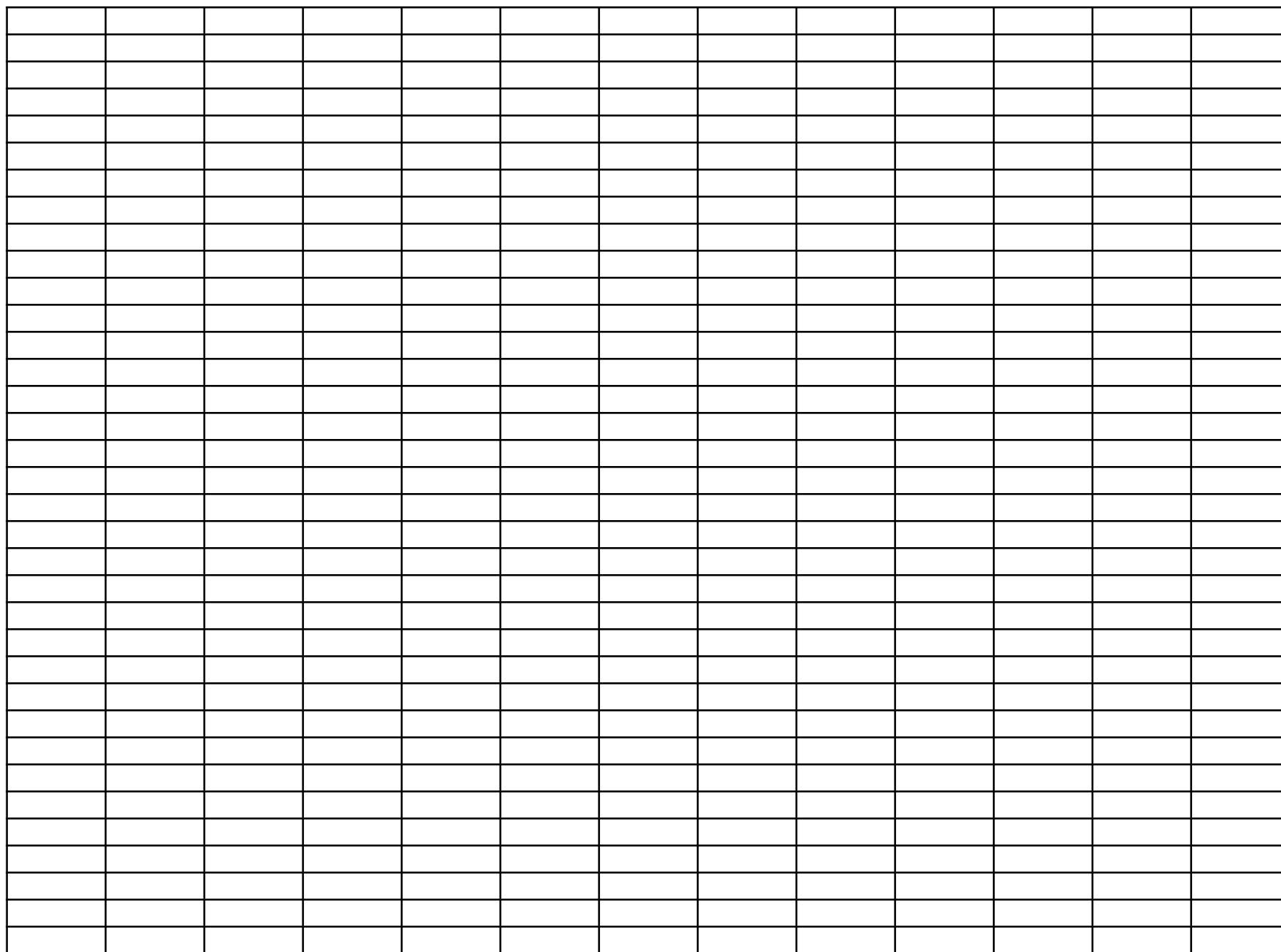


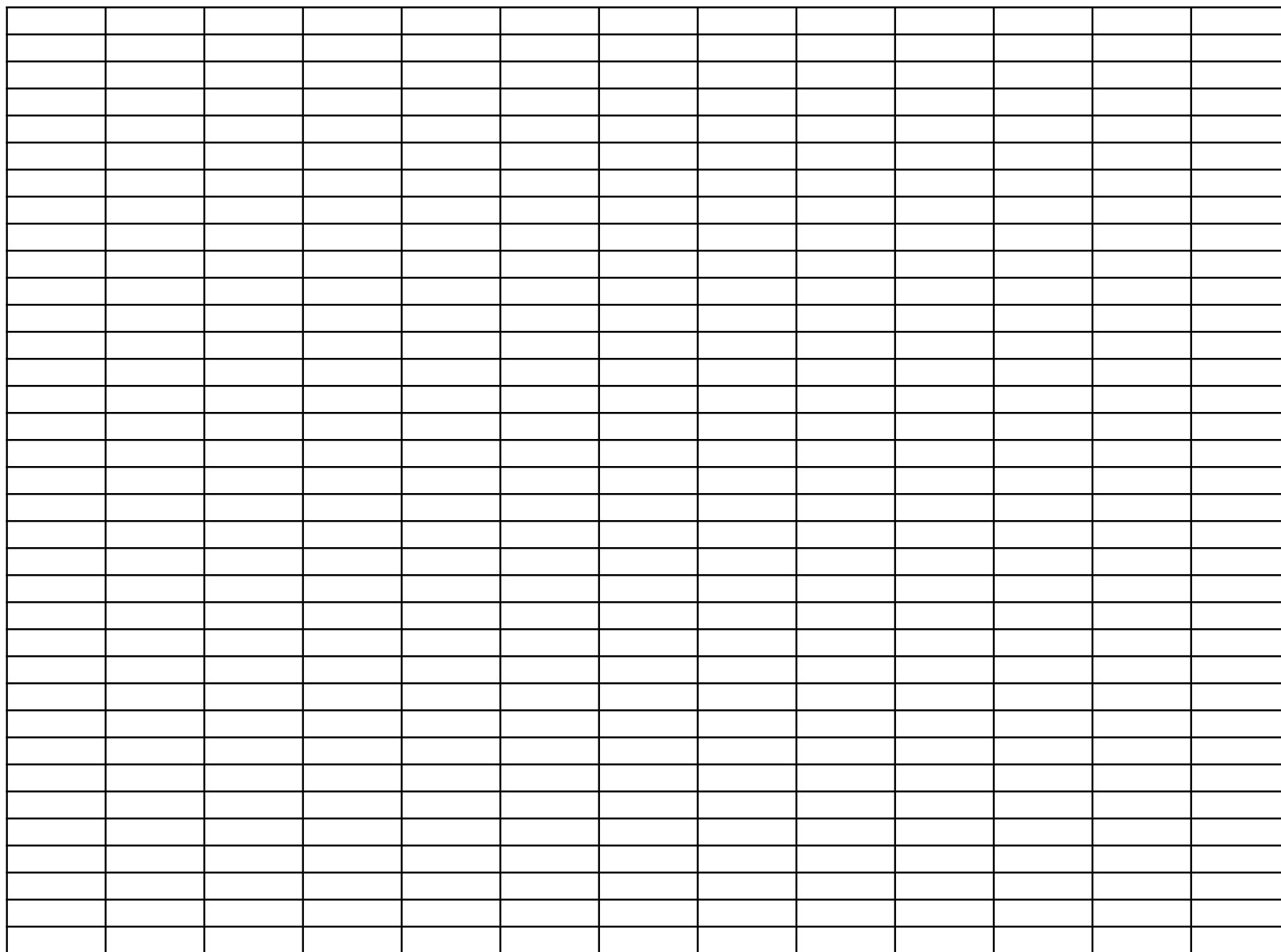


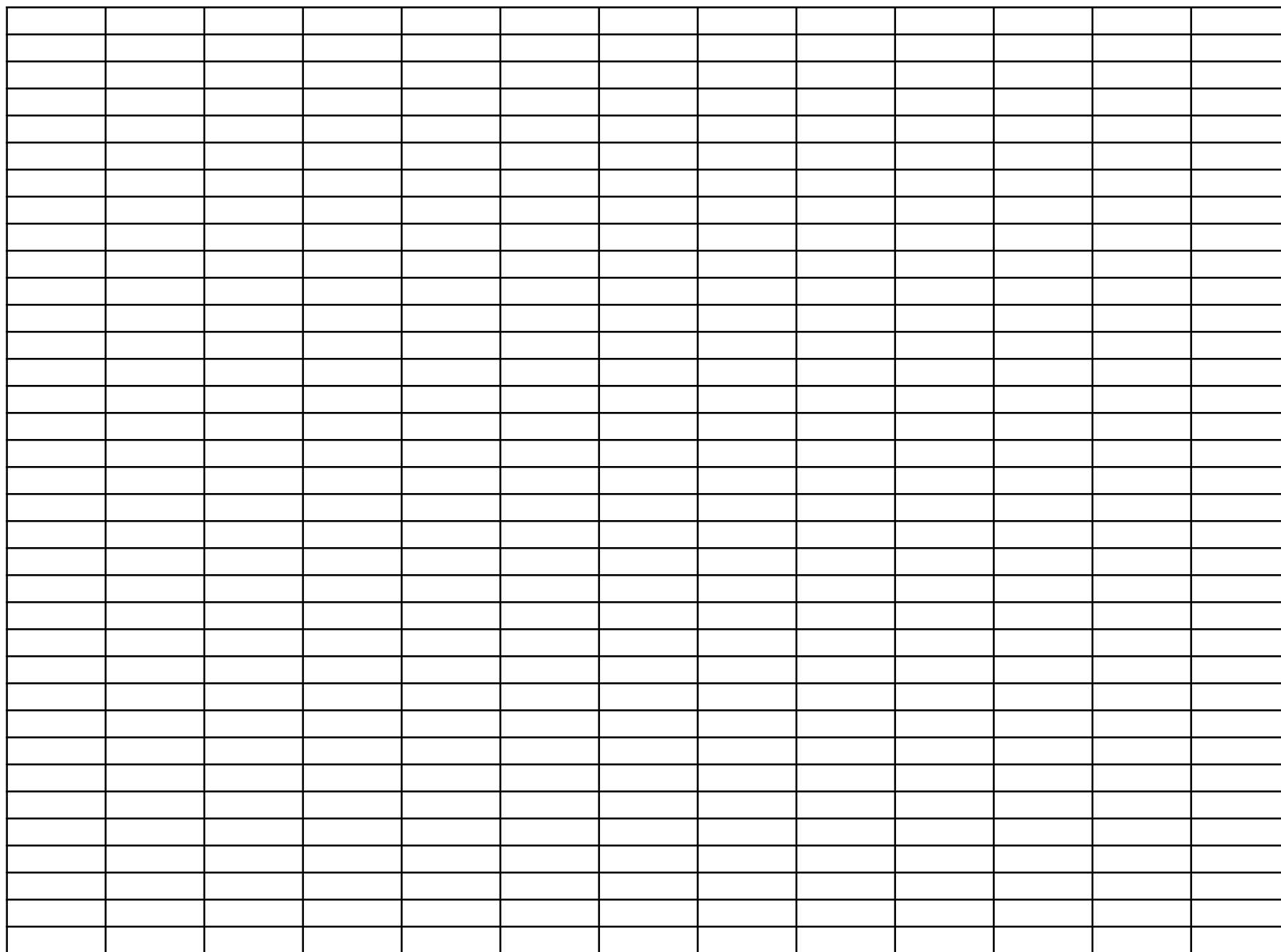


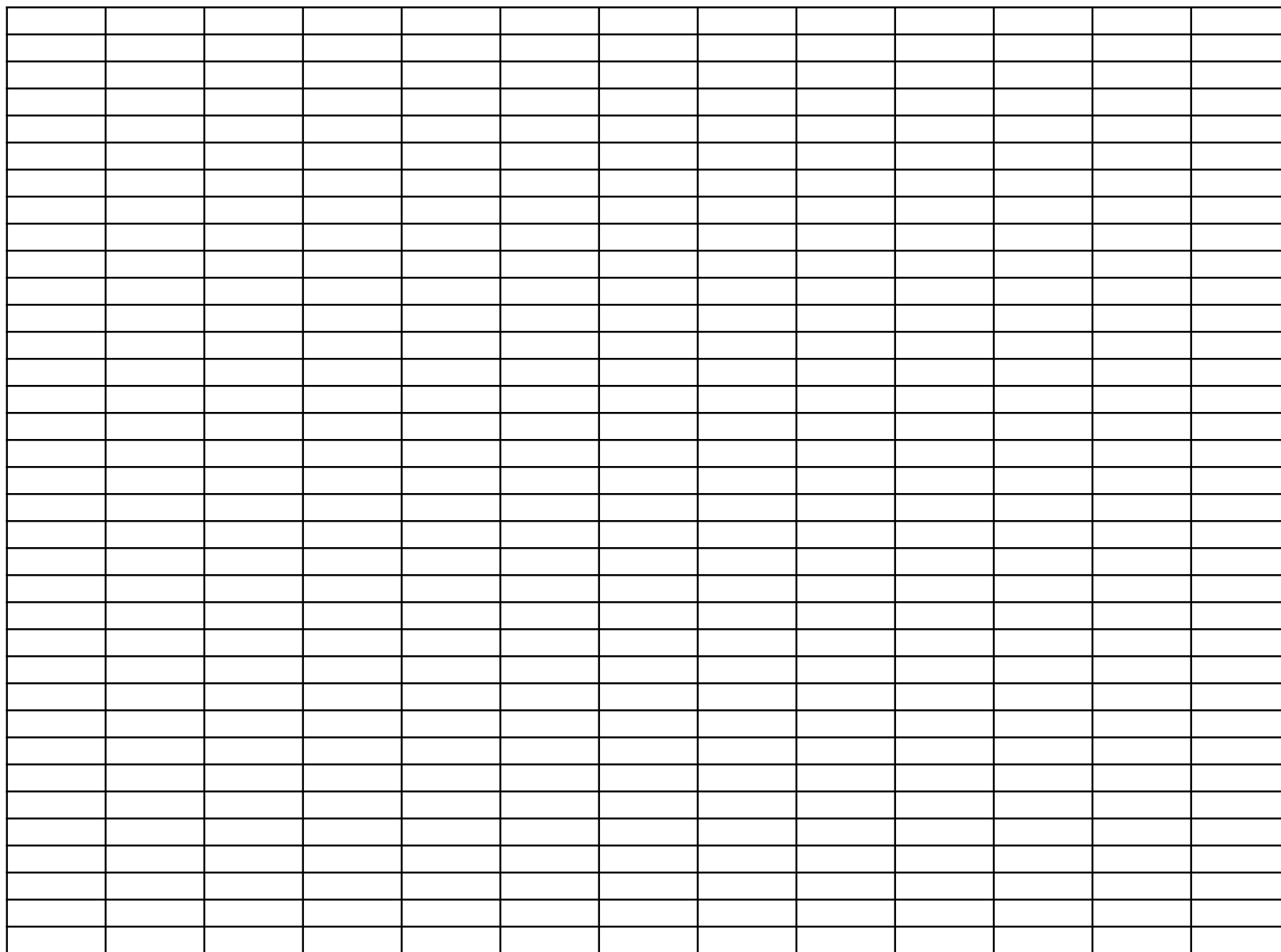


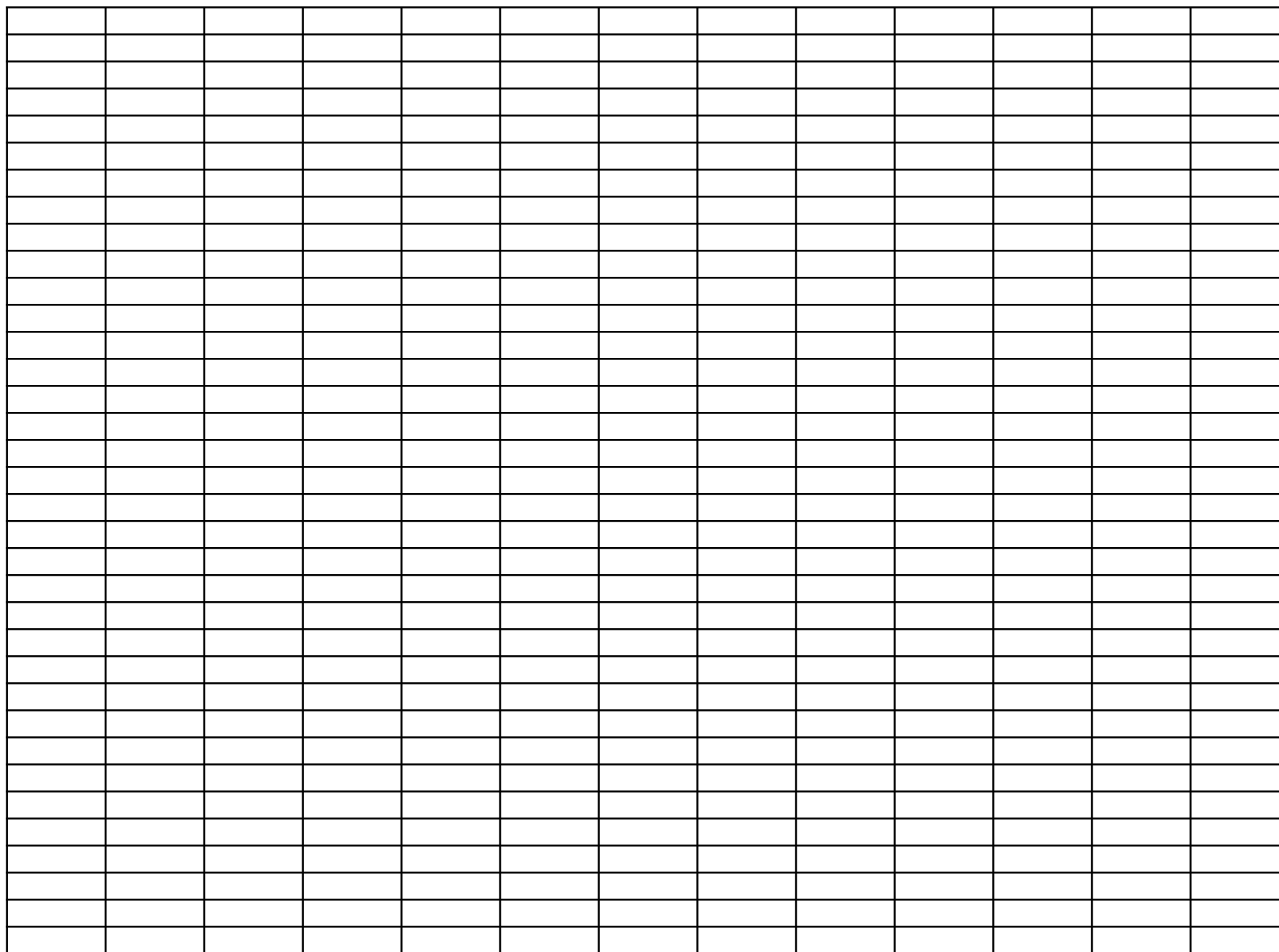


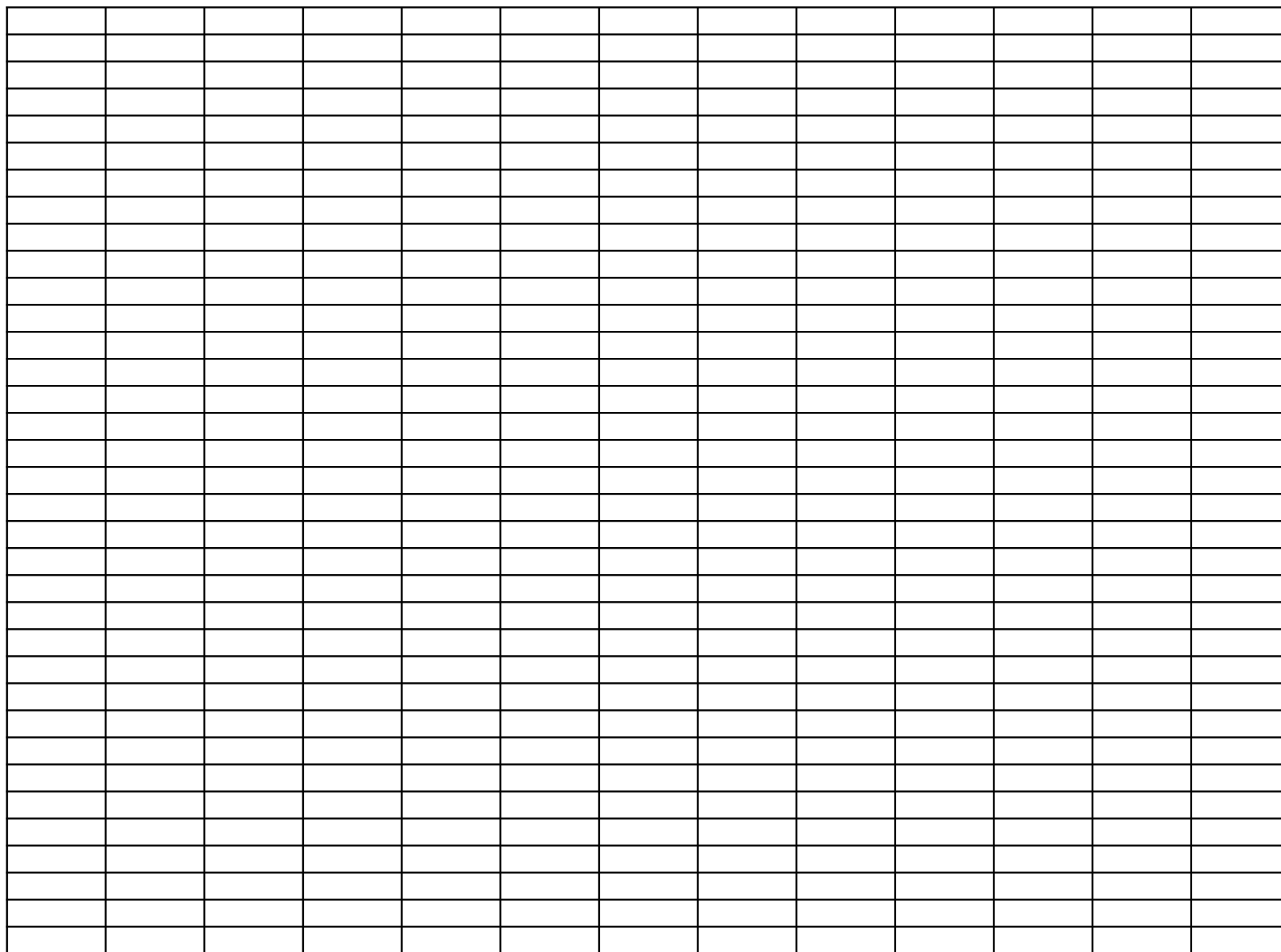


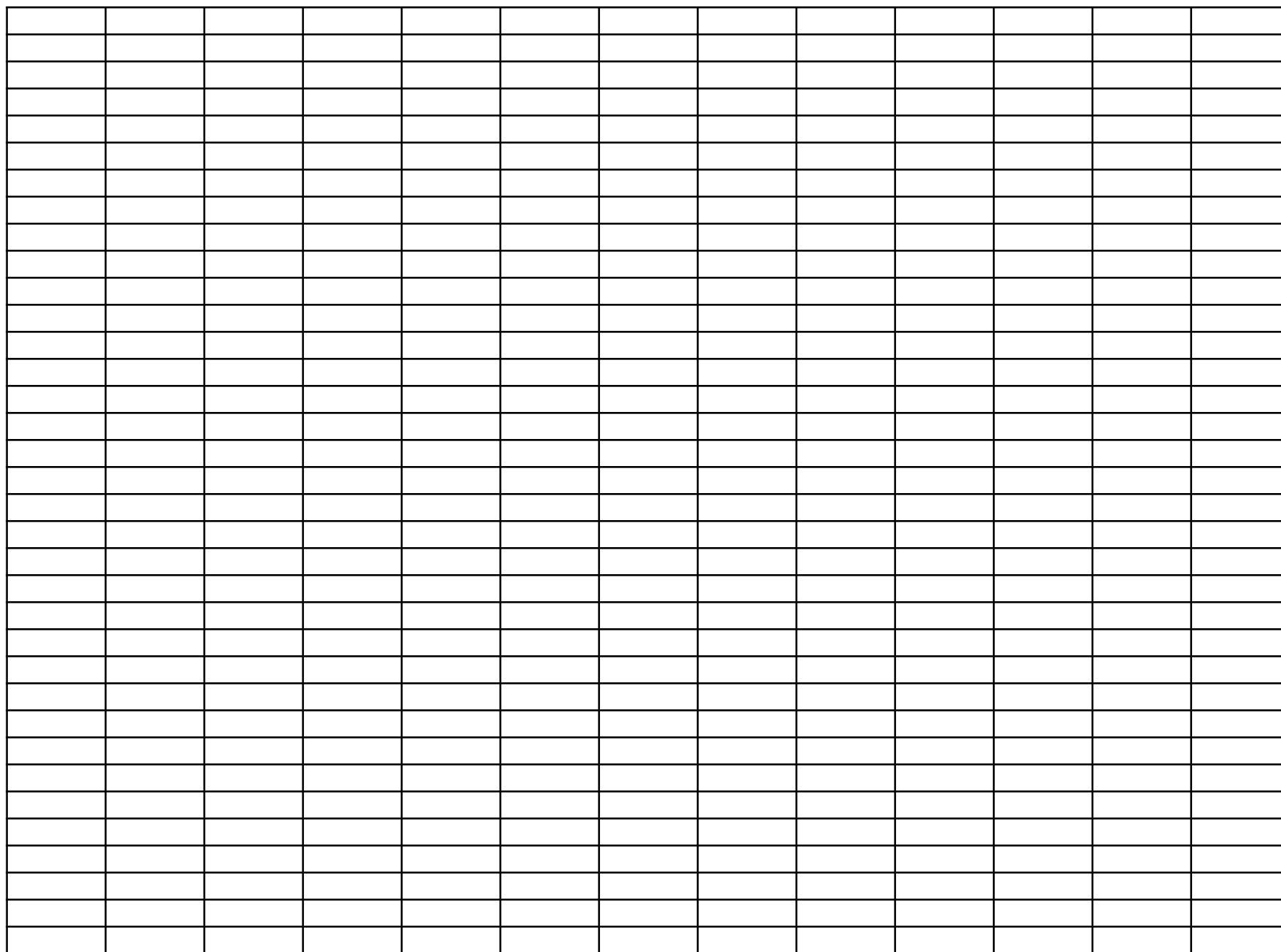


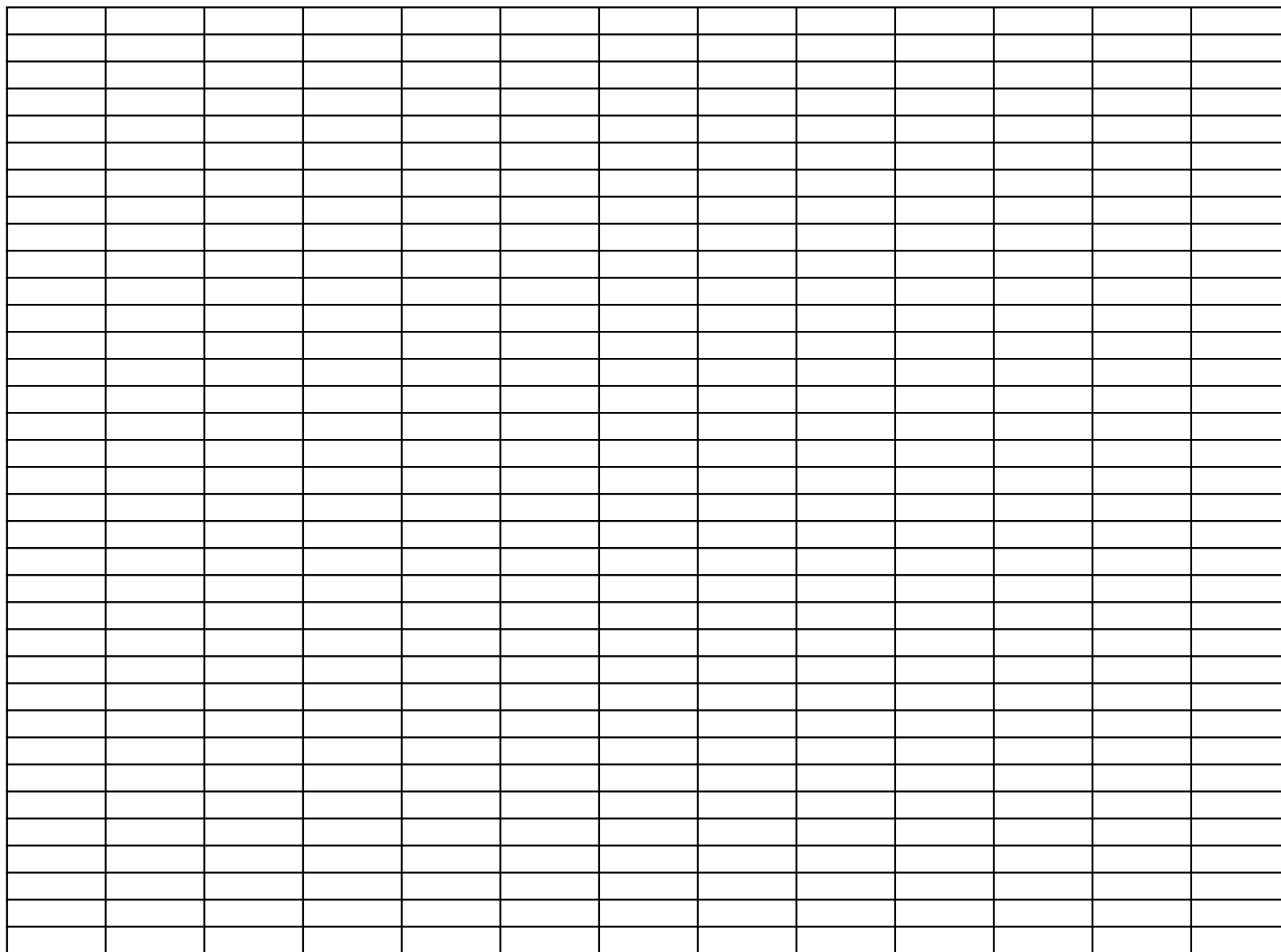


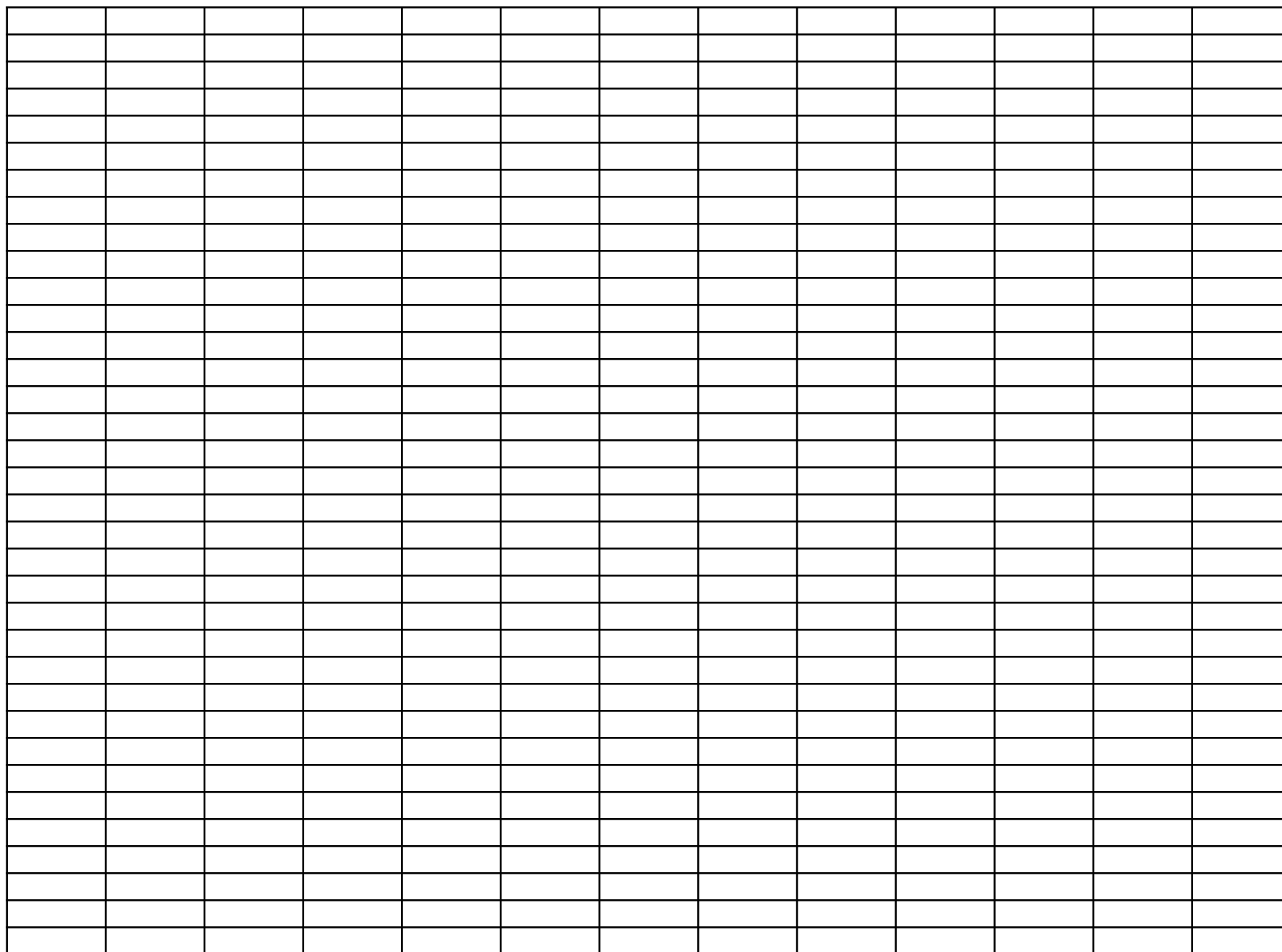


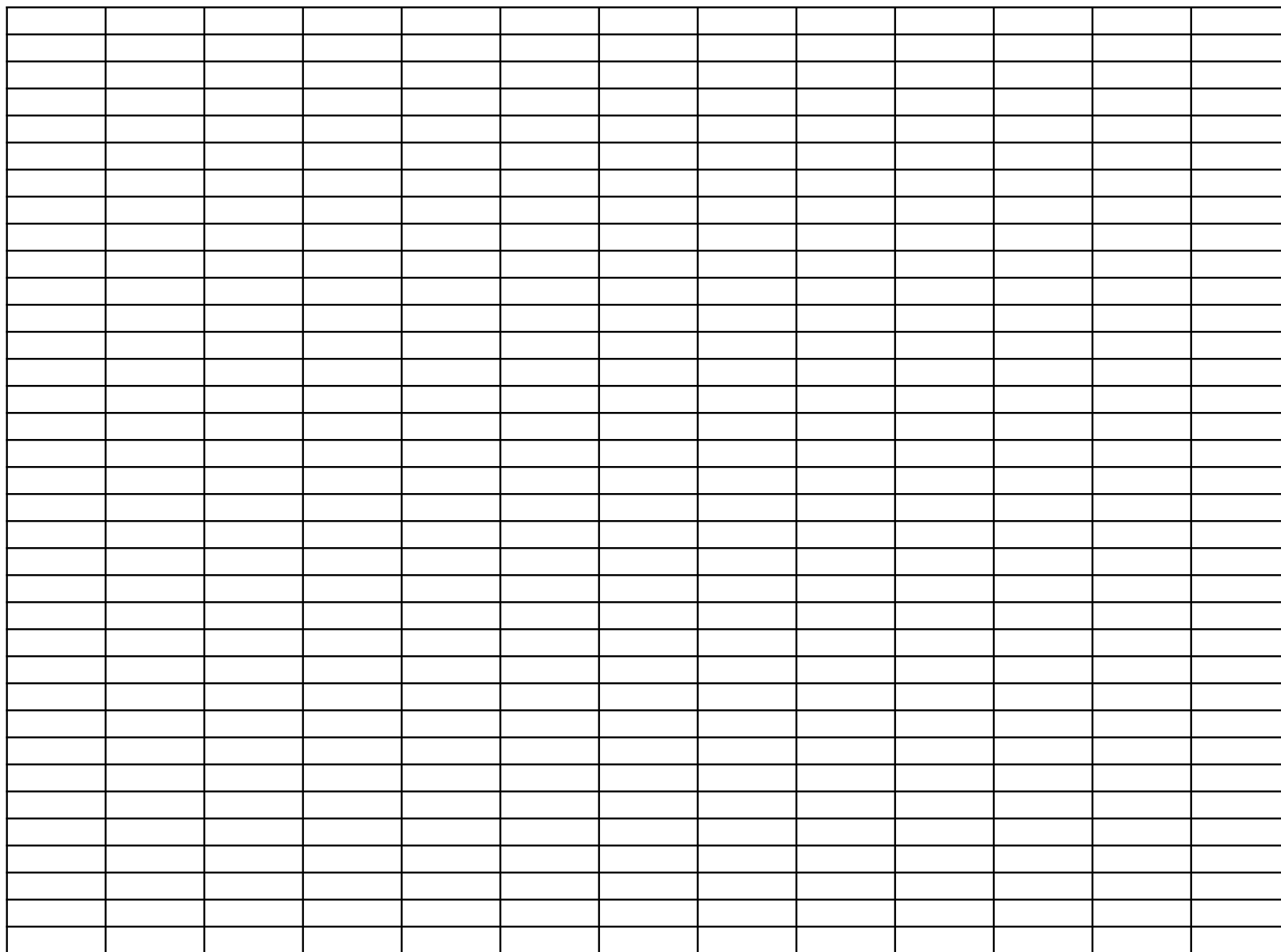


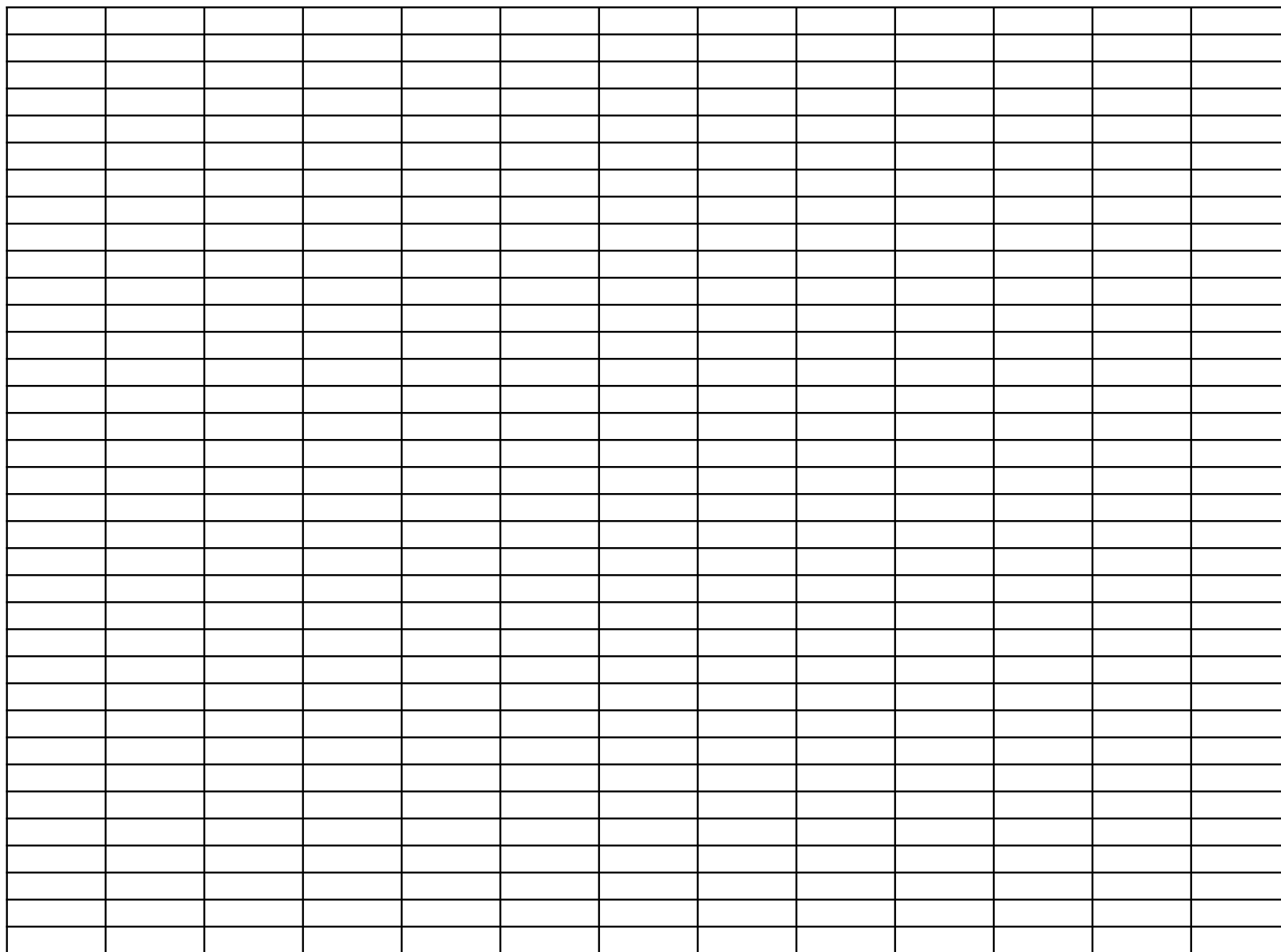


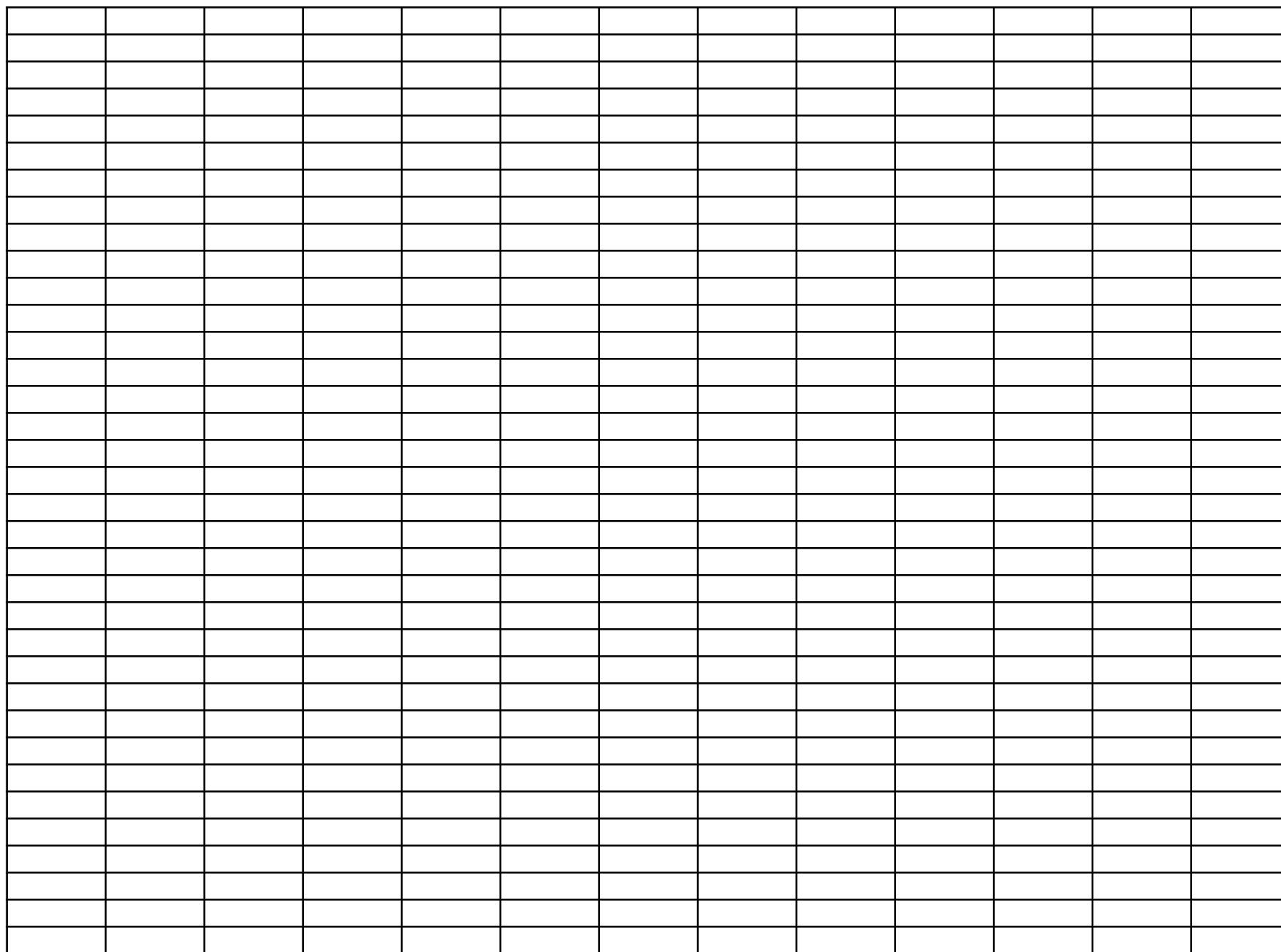


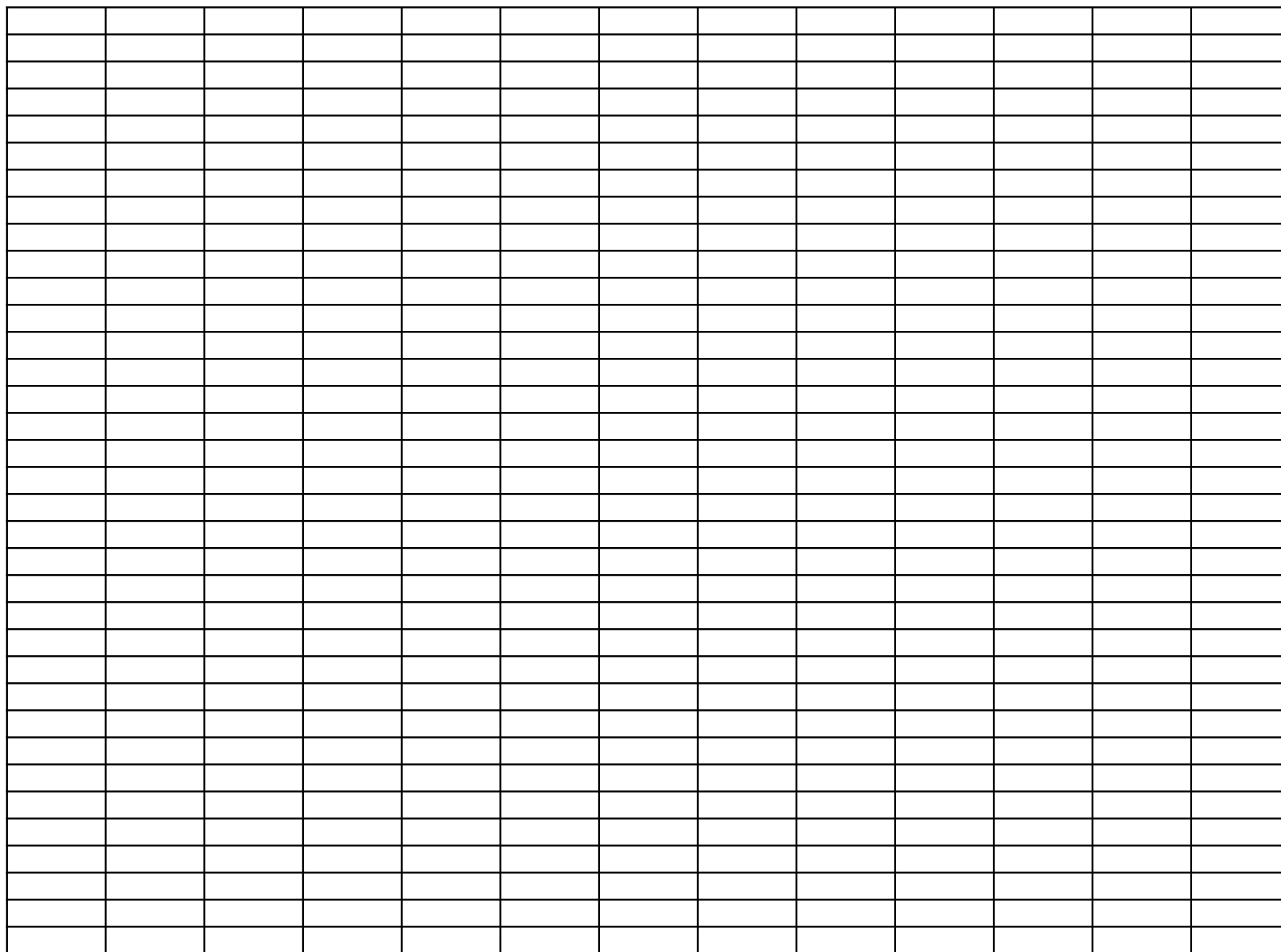


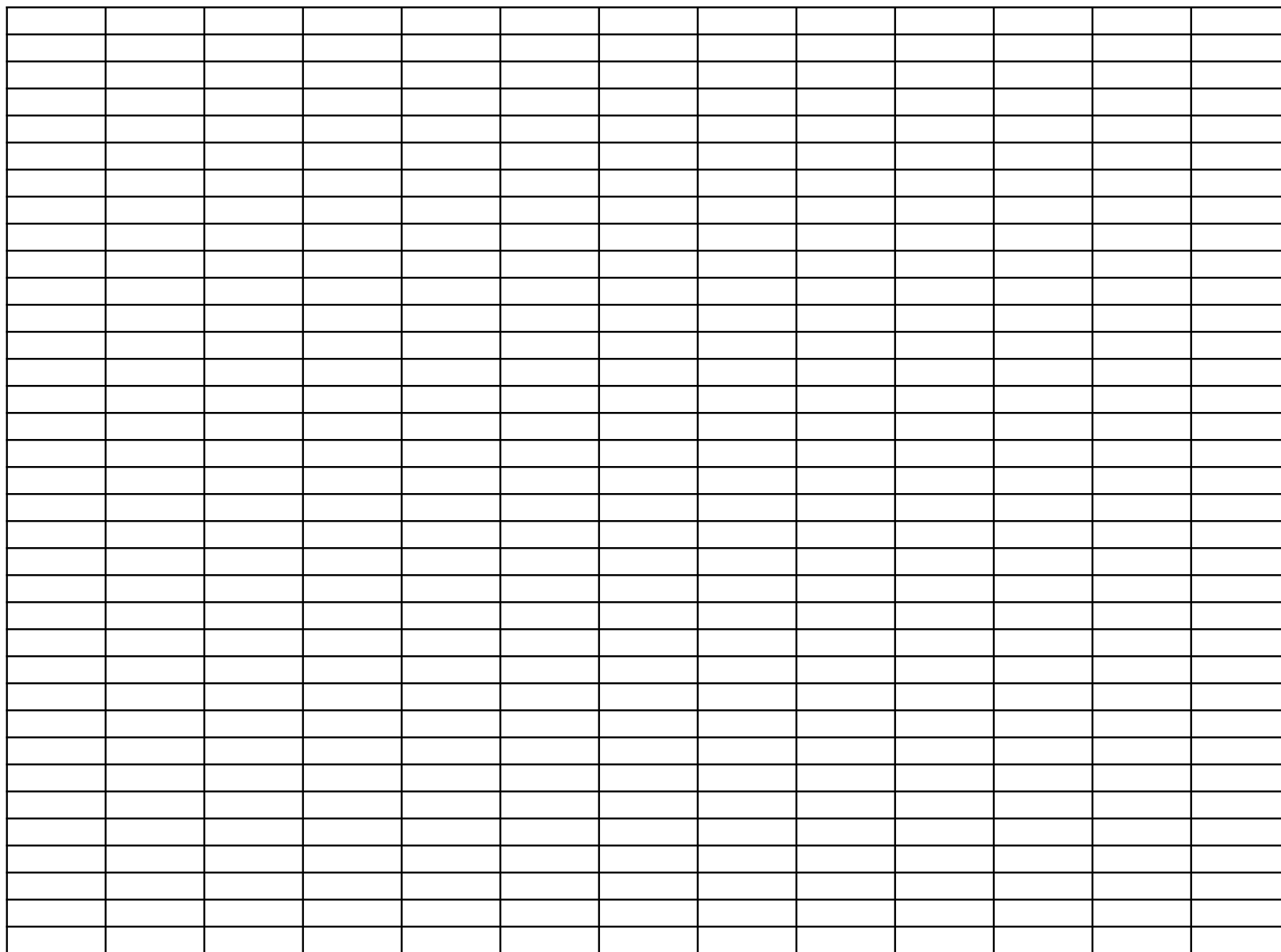


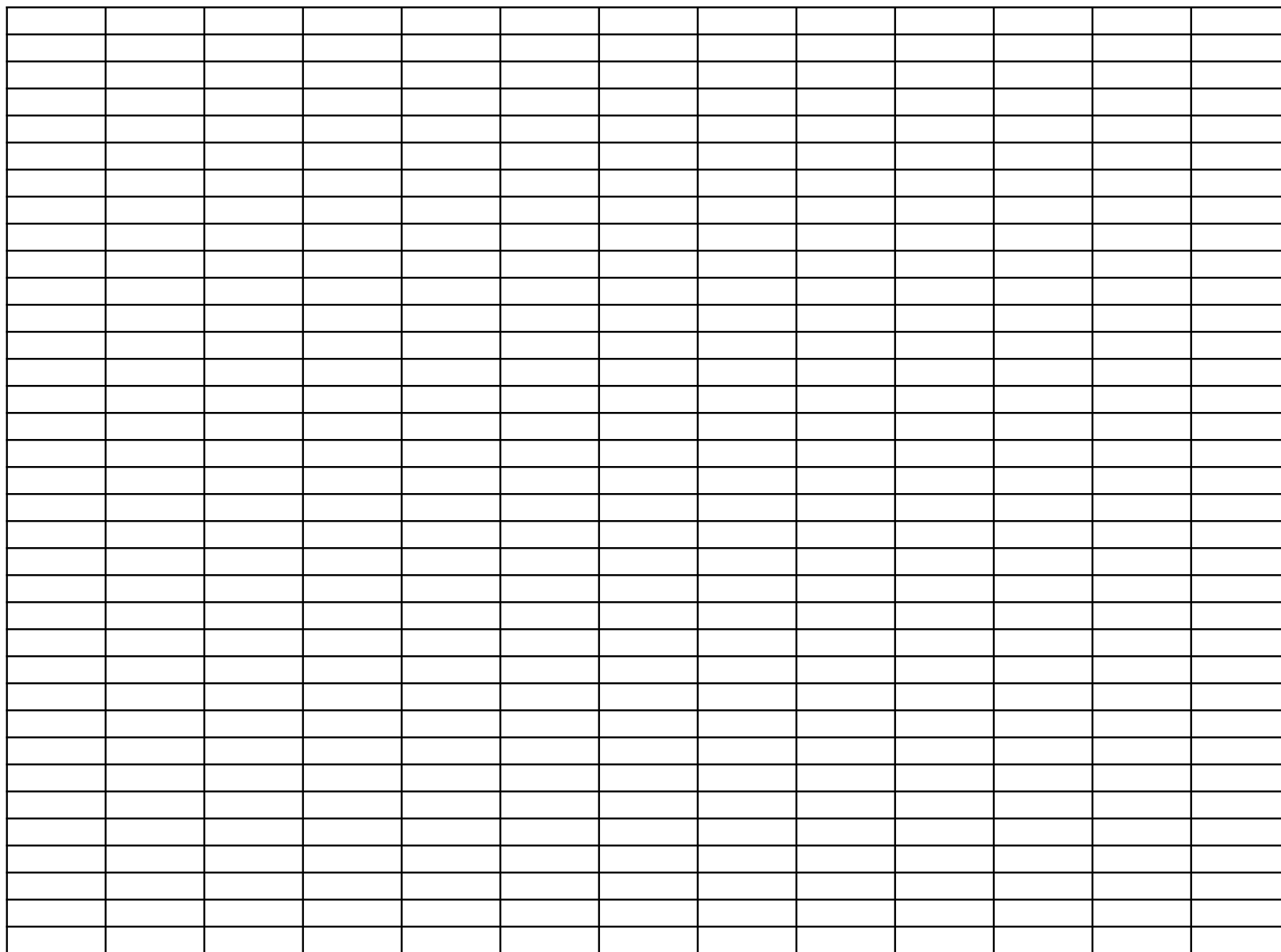


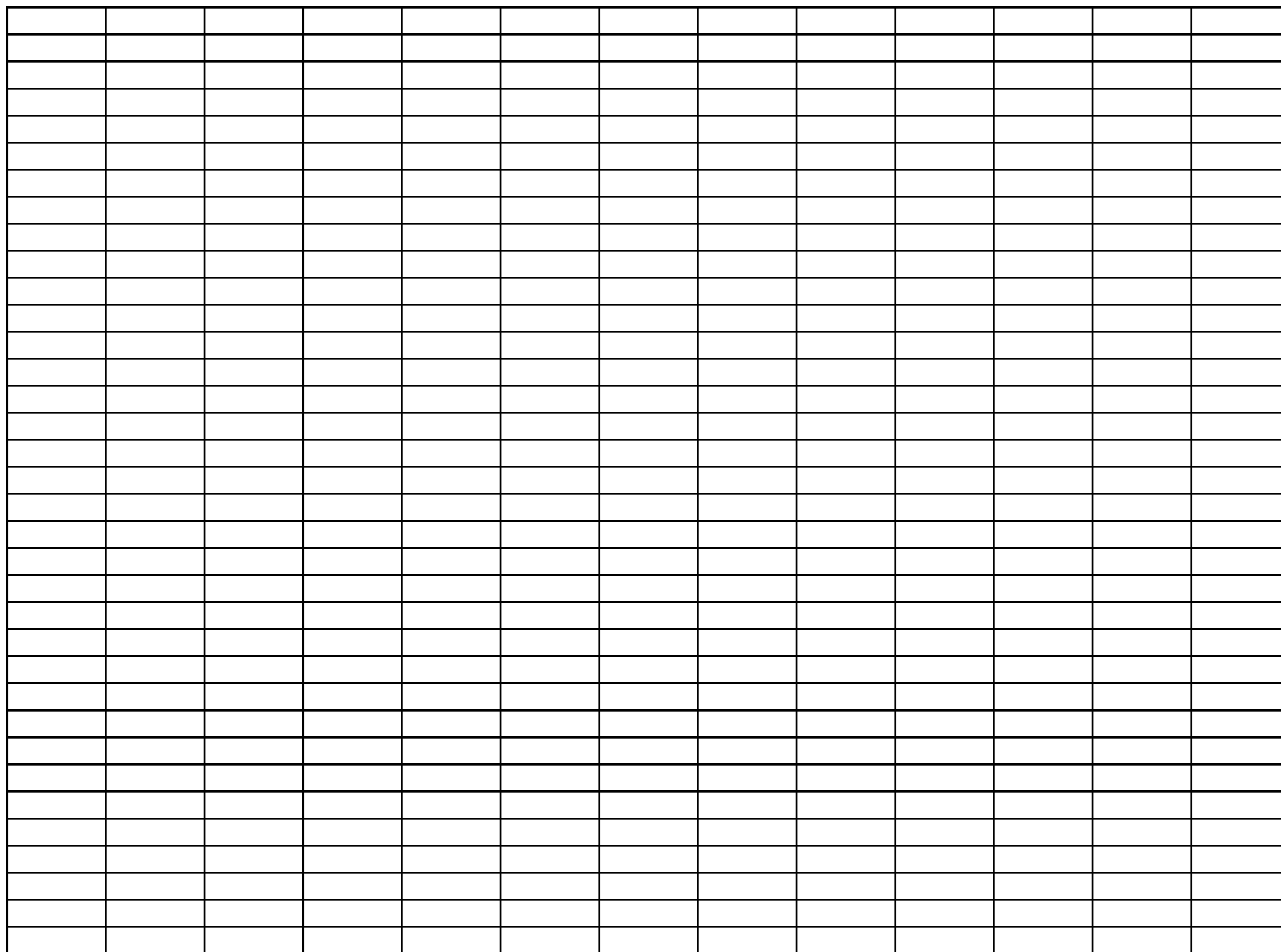


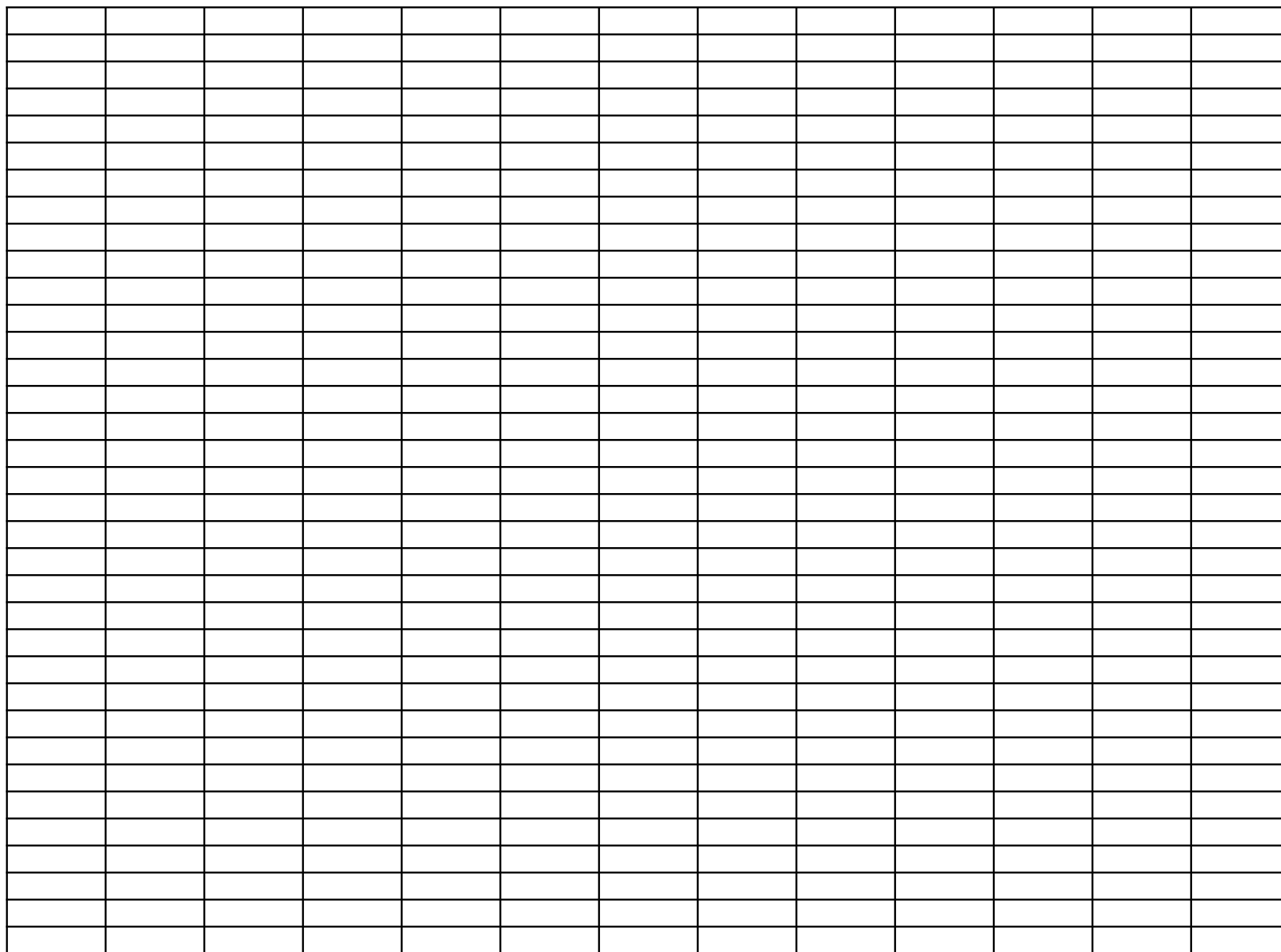


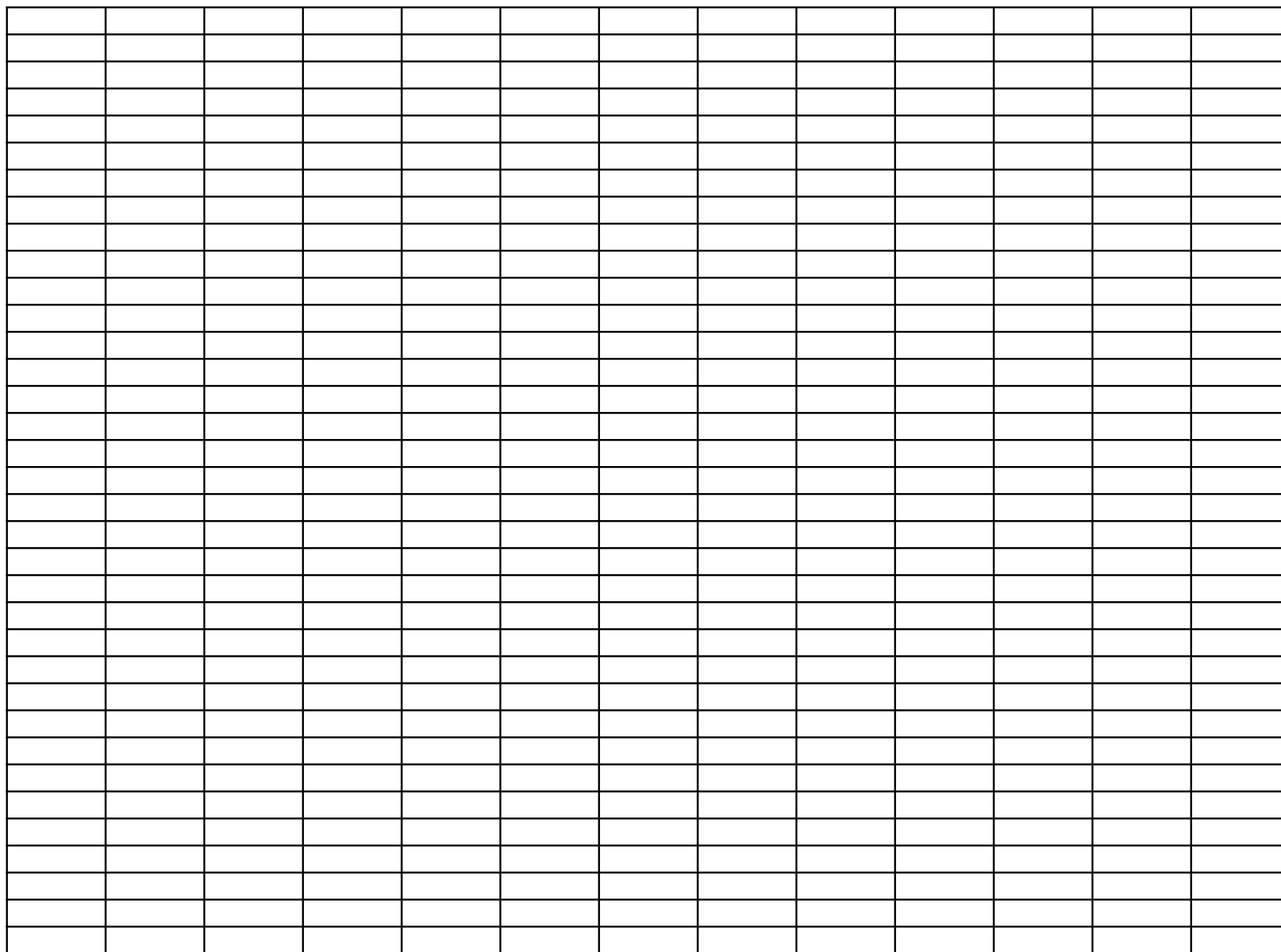


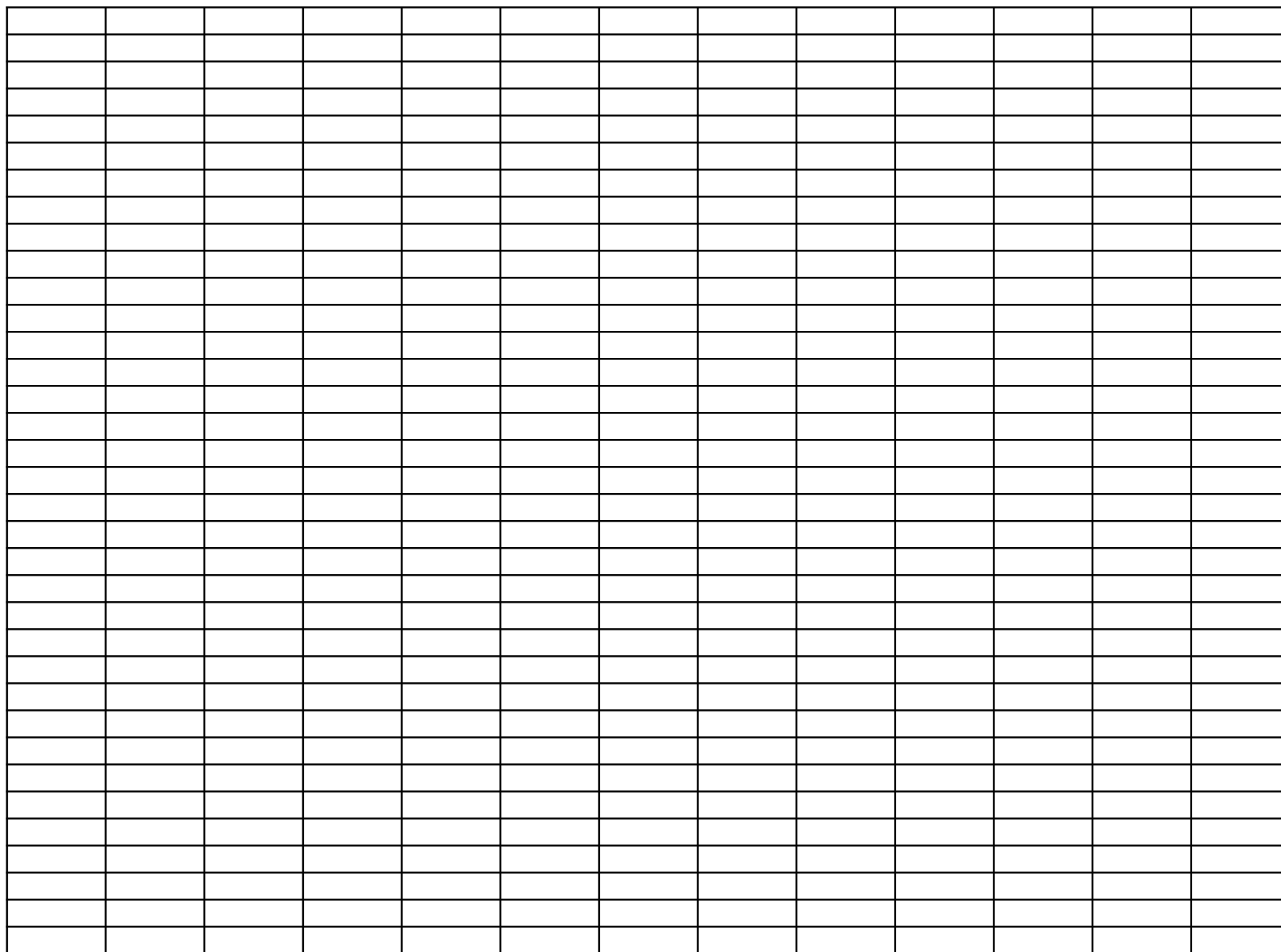


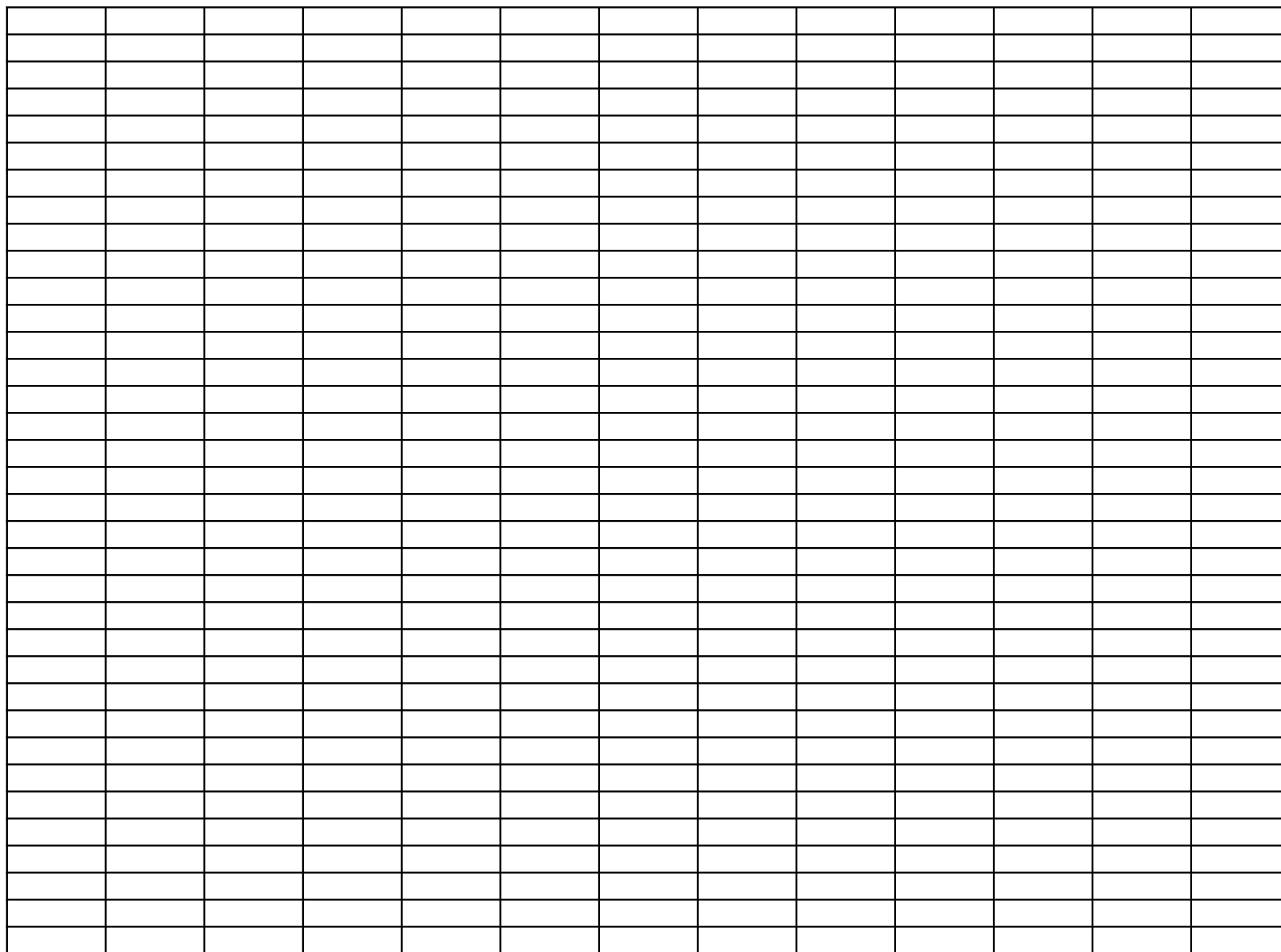


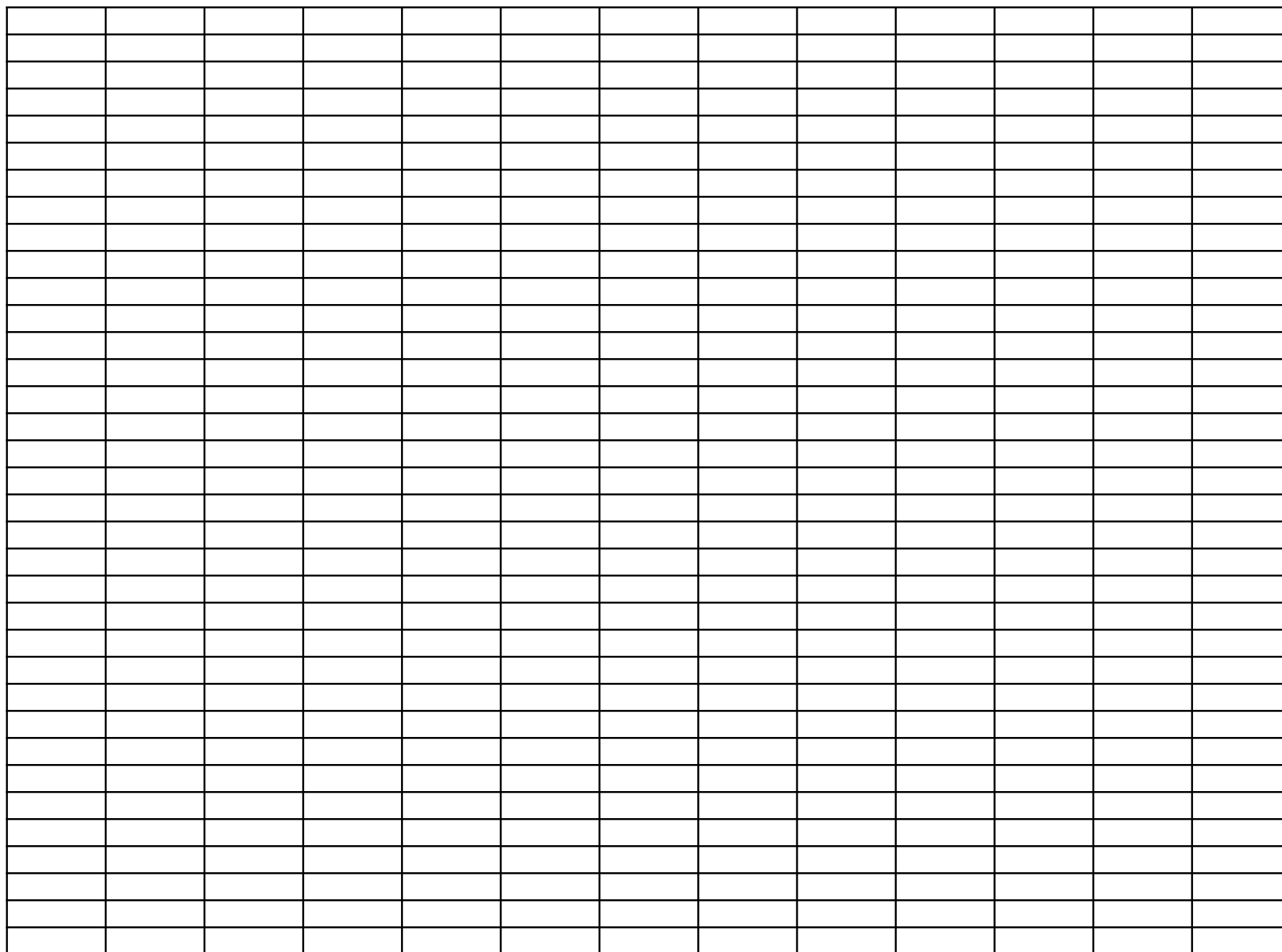


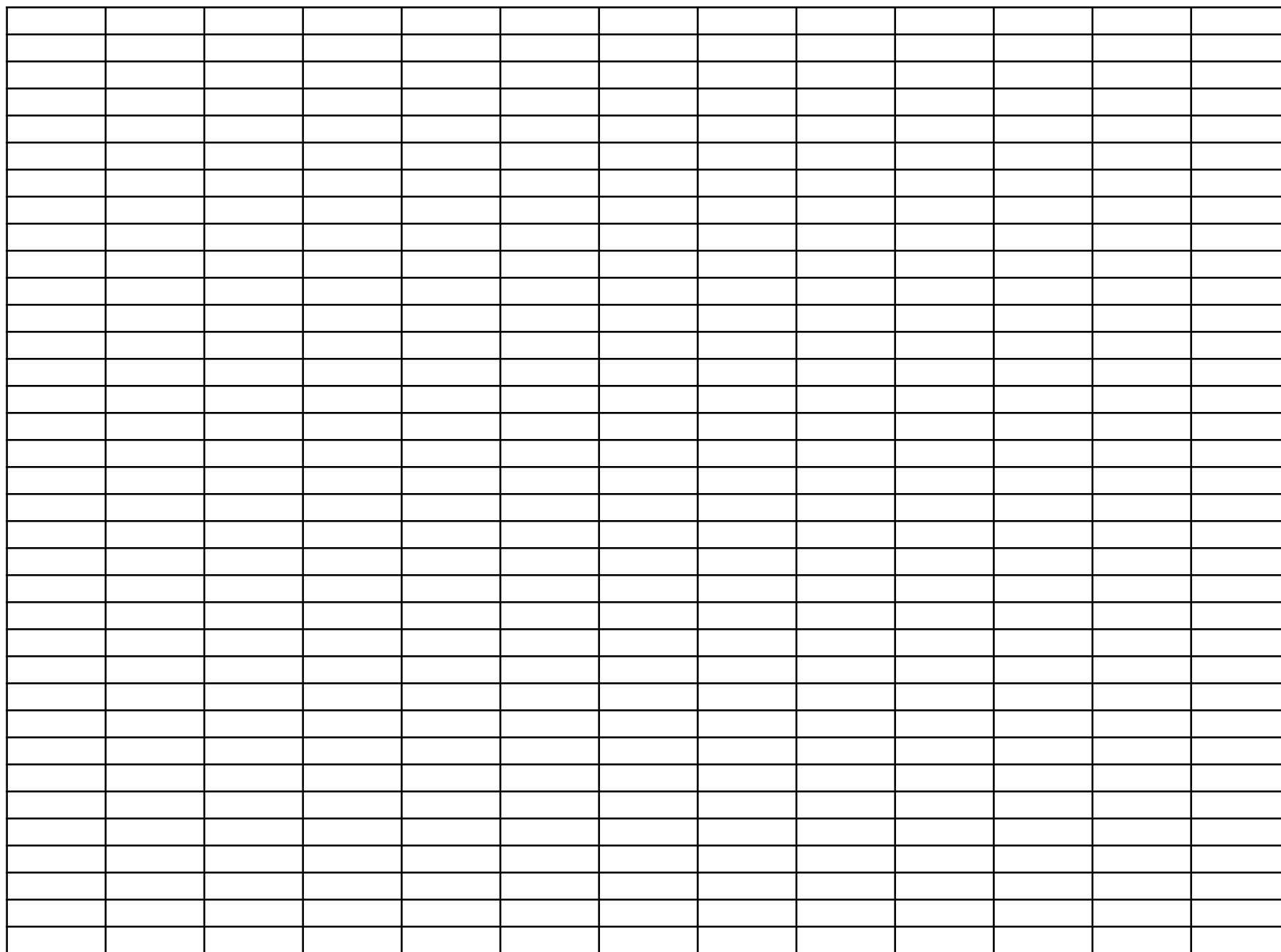


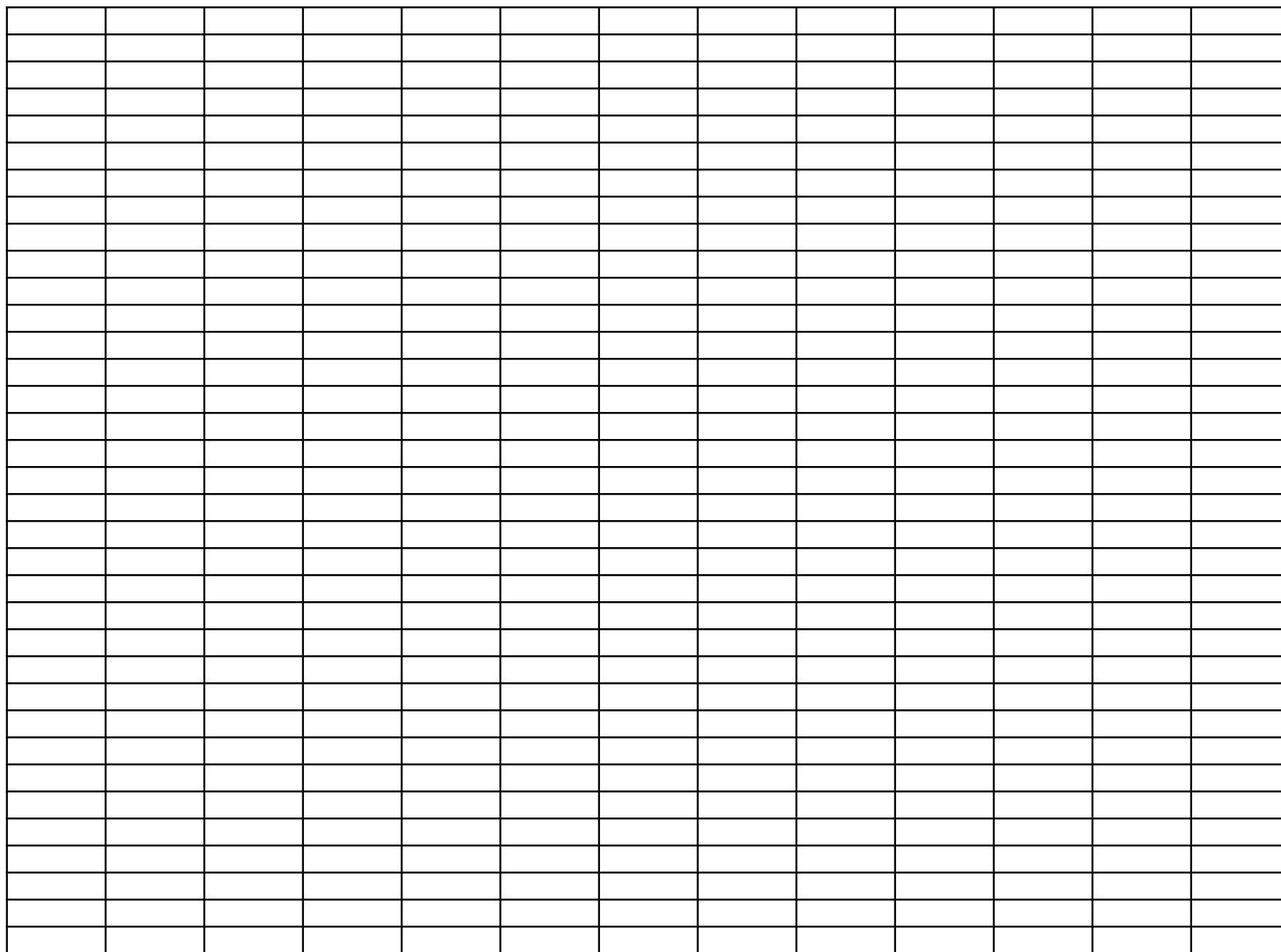
